Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that you were eligible for the Essential Plan, for a limited time, effective May 1, 2017?

Did NY State of Health properly determine that you were not eligible for Medicaid?

Procedural History

On March 17, 2017, NY State of Health (NYSOH) received your updated application for financial assistance with health insurance.

On March 18, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible for the Essential Plan, for a limited time, effective May 1, 2017. This notice also stated that you needed to submit income documentation to confirm your eligibility by June 15, 2017.

Also on March 18, 2017, NYSOH issued a plan enrollment notice confirming your enrollment in the Essential Plan, effective May 1, 2017.

On May 11, 2017, you spoke to NYSOH's Account Review Unit and appealed the eligibility determination insofar as you were not found eligible for Medicaid.

On May 18, 2017, NYSOH issued an eligibility determination notice stating that you were eligible for Medicaid, effective May 1, 2017 because you had been granted Aid to Continue until a decision was made on your appeal.

Also on May 18, 2017, NYSOH issued a plan enrollment notice confirming your enrollment in a Medicaid Managed Care plan, effective May 1, 2017.

On August 28, 2017, you were scheduled for a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. You requested that day that the hearing be adjourned to a later date; which was granted.

On September 7, 2017, you had an adjourned telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. Under oath, you waived your right to formal notice of telephone hearing. The record was developed during the hearing and the record was held open until September 22, 2017, to allow you time to submit supporting documents.

On September 22, 2017, you contacted NYSOH's Accounts Review Unit and requested an extension to submit the supporting documents. On September 25, 2017, a nine-page fax was viewable in your NYSOH account. This nine-page fax was entered into the record as "Appellant's Exhibit #1", and the record was closed that day.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of single. You will claim no dependents on that tax return.
- 2) You are seeking insurance for yourself.
- 3) The application that was submitted on March 17, 2017 listed an annual household income of \$18,200.00, consisting of income you earn from your employment. You testified that you are unsure if this amount is correct.
- 4) You testified that you work two different jobs, and get paid biweekly in both jobs.
- 5) You testified that the number of hours you work at both jobs can vary depending on many different factors.
- 6) You provided income documentation in the form of biweekly paystubs from one employer for the month of March 2017; dated March 2, 2017 for a gross income amount of \$647.22, March 17, 2017 for a gross income

amount of \$731.38, and March 31, 2017 for a gross income amount of \$714.31.

- 7) You provided income documentation in the form of one biweekly pay stub from your second employer for the month of March 2017; dated March 17, 2017 for a gross income amount of \$511.29.
- 8) Your application states that you will not be taking any deductions on your 2017 tax return.
- 9) Your application states that you live in Dutchess County.
- 10) You testified that you cannot afford your health insurance on top of your other living expenses, and that you also need coverage for dental and vision benefits.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present noncitizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one -person household (81 Fed. Reg. 4036).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see https://www.medicaid.gov/basic-health-program.html).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one -person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Modified Adjusted Gross Income

NYSOH bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code (45 CFR § 155.300(a)). The term "modified adjusted gross income" means adjusted gross income increased by (1) any income that was excluded under 26 USC § 911 for United States citizens or residents living abroad, (2) tax-exempt interest received or accrued, and (3) Social Security benefits that were excluded from gross income under 26 USC § 86 (see 26 USC § 36B(d)(2)(B), 26 CFR § 1.36B-1(e)(2)).

"Adjusted gross income" means, in the case of an individual taxpayer, gross federal taxable income minus certain specific deductions, such as expenses reimbursed by an employer, losses from sale or exchange of property, losses from premature withdrawal of finds from time savings accounts, deductions attributable to royalties, and certain retirement savings (26 USC § 62(a)). Living

expenses, such as rent and utilities are not an allowable deduction in computing adjusted gross income.

Verification Process

For all individuals whose income is needed to calculate the household's eligibility, NYSOH must request data that will allow NYSOH to verify the household's income (45 CFR §155.320(c)(1)(i), 42 CFR § 435.945).

If NYSOH cannot verify the income information required to determine eligibility they must attempt to resolve the inconsistency including giving the applicant the opportunity to submit satisfactory documentary evidence (45 CFR §155.315(f) 42 CFR § 435.952).

Legal Analysis

The first issue under review is whether NYSOH properly determined that you were eligible for the Essential Plan, for a limited time, effective May 1, 2017.

The application that was submitted on March 17, 2017 listed an annual household income of \$18,200.00. During the hearing, you testified that you were unsure if the amount you provided in your application was correct due to the nature of your employment. However, you asked that your current expenses, which include rent, electricity and other living expenses, be considered when calculating your annual household income.

Since the Internal Revenue Service rules do not allow living expenses such as rent, electricity and other living expenses to be deducted from the calculation of your adjusted gross income, they cannot be deducted when NYSOH computes your modified adjusted gross income for Essential Plan purposes. Therefore, NYSOH correctly determined your household income to be \$18,200.00, and the eligibility determination relied upon that information.

You are in a one-person household. You expect to file your 2017 income taxes as single and will claim no dependents on that tax return.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,880.00 for a one-person household. Since an annual household income of \$18,200.00 is 153.20% of the 2016 FPL, NYSOH properly found you to be eligible for the Essential Plan, for a limited time, effective May 1, 2017.

The second issue is whether NYSOH properly determined that you were ineligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$12,060.00 for a one-person household. Since \$18,200.00 is 150.91% of the 2017 FPL, NYSOH properly found you to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

You testified that you work two jobs, and that you are paid biweekly from both jobs. You further testified that the number of hours you work per week at both jobs can vary.

You faxed three biweekly paystubs from one employer for March 2017; dated March 2, 2017 for a gross income amount of \$647.22, March 17, 2017 for a gross income amount of \$731.38, and March 31, 2017 for a gross income amount of \$714.31.

You also faxed one biweekly paystub from your second employer for March 2017; dated March 17, 2017 for a gross income amount of \$511.29. However, you testified that you are paid biweekly from both employers, but you only submitted one paystub from this employer for the month of March 2017. There is also no indication in the record that you only worked for two weeks in March 2017 for this employer.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,387.00 per month. Even with the missing income documentation, the income documentation you did provide shows that you earned at least \$2,604.20 in March 2017; which is greater than \$1,387.00. Therefore, you do not qualify for Medicaid on the basis of monthly income as of the date of your application.

Since the March 18, 2017 eligibility determination properly stated that, based on the information you provided, you were eligible for the Essential Plan, for a limited time, and ineligible for Medicaid, it is correct and is AFFIRMED.

Decision

The March 18, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

NYSOH properly found you eligible for the Essential Plan, for a limited time, effective May 1, 2017.

NYSOH properly found you ineligible for Medicaid.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
