Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you and your spouse did not qualify to enroll in a qualified health plan outside of the open enrollment period?

Procedural History

On March 20, 2017, NYSOH received your application for health insurance.

On March 21, 2017, NYSOH issued an eligibility determination notice stating that you and your spouse were eligible to receive an advance premium tax credit of up to \$488.00 per month, effective May 1, 2017. You and your spouse subsequently enrolled in a qualified health plan.

On May 13, 2017, you contacted NYSOH and unsuccessfully attempted to enroll into a new qualified health plan.

Also on May 13, 2017, you spoke to NYSOH's Account Review Unit and appealed you and your spouse's inability to enroll in a health plan outside of the open enrollment period.

On May 20, 2017, NYSOH issued an eligibility determination notice stating that you and your spouse did not qualify for a special enrollment period, effective July 1, 2017.

On August 18, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) On March 20, 2017, you submitted an application for health insurance.
- 2) Also on March 20, 2017 NYSOH determined you and your spouse eligible to receive an advance premium tax credit of up to \$488.00 per month, effective May 1, 2017.
- 3) You and your spouse subsequently enrolled in a qualified health plan effective May 1, 2017.
- 4) You testified that on March 20, 2017, when you were selecting a plan for enrollment, that a NYSOH representative did not advise you that there was a difference between the deductible in the Healthfirst silver level qualified health plan and bronze level qualified health plan.
- 5) You testified that you selected a bronze level qualified health plan for you and your spouse. You testified that once you found out the amount of the deductible for the bronze level plan, that you contacted NYSOH in an effort to change to a silver level qualified health plan.
- 6) You testified that on May 13, 2017 that you were unable to select a new qualified health plan for you and your spouse.
- 7) You testified that on May 13, 2017 that you contacted NYSOH and was verbally denied a special enrollment period.
- 8) You testified that since filing your application on March 20, 2017 there have been no other major changes to your household.
- 9) You testified that if you had been given accurate information by the NYSOH representative on March 20, 2017, that you would have selected a silver level plan and not a bronze level qualified health plan for you and your spouse.
- 10) NYSOH records contain an Incident [REDACTED], dated April 24, 2017 which includes the results of a call pull from March 20, 2017. The notes state that "At 26 minutes 58 seconds into the call, the consumer was provided the price and deductible for the Healthfirst Bronze plan and

she stated that she wanted to confirm provider participation. After calling the provider she returned to the line and stated that she would like to select the bronze level plan '100 percent' at 32 minutes 35 seconds."

11) You testified that you received a notice dated May 20, 2017 stating that you and your spouse did not qualify for a special enrollment period and that you are appealing that determination.

12) You testified that you are seeking a special enrollment period to allow you and your spouse to enroll in a silver level qualified health plan which has a lower deductible.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Enrollment in a Qualified Health Plan

NYSOH must provide annual open enrollment periods during which time qualified individuals may enroll in a qualified health plan and enrollees may change qualified health plans (45 CFR § 155.410(a)(1)).

For the benefit year beginning on January 1, 2017, the annual open enrollment period began on November 1, 2016, and extended through January 31, 2017 (45 CFR § 155.410(e)(2)).

Special Enrollment Periods

After each open enrollment period ends, NYSOH provides special enrollment periods to qualified individuals. During a special enrollment period, a qualified individual may enroll in a qualified health plan, and an enrollee may change their enrollment to another plan. This is generally permitted when one of the following triggering events occur:

- (1) The qualified individual or his or her dependent either:
 - (i) Loses minimum essential coverage.
 - (ii) Is enrolled in any non-calendar year group health plan or individual health insurance coverage, even if the qualified individual or his or her dependent has the option to renew such coverage.
 - (iii) Loses pregnancy-related coverage.

(iv) Loses medically needy coverage as described under section 1902(a)(10)(C) of the Social Security Act only once per calendar year.

(2)(i) The qualified individual gains a dependent or becomes a dependent through marriage, birth, adoption, placement for adoption, or placement in foster care, or through a child support order or other court order.

(ii) the enrollee loses a dependent or is no longer considered a dependent through divorce or legal separation as defined by State law in the State in which the divorce or legal separation occurs, or if the enrollee, or his or her dependent, dies.

(3) The qualified individual, or his or her dependent, becomes newly eligible for enrollment in a qualified health plan because he or she gains citizenship, status as a national, or lawful present or is no longer incarcerated.

(4) The qualified individual's or his or her dependent's, enrollment or non-enrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities.

(5) The enrollee or, his or her dependent adequately demonstrates to NYSOH that the qualified health plan in which he or she is enrolled substantially violated a material provision of its contract in relation to the enrollee;

(6) The enrollee or enrollee's dependent is newly eligible or ineligible for advance payments of the premium tax credit, or change in eligibility for cost-sharing reductions.

(7) The qualified individual or enrollee, or his or her dependent, gains access to new qualified health plan as a result of a permanent move and either—

(i) Had minimum essential coverage for one or more days during the 60 days preceding the date of the permanent move, or

(ii) Was living outside of the United States or in a United States territory at the time of the permanent move;

(8) The qualified individual or dependent who gains or maintains status as an Indian may enroll in a qualified health plan or change from one plan to another, once per month.

(9) The qualified individual or enrollee, or his or her dependent, demonstrates to the Exchange, in accordance with guidelines issued by HHS, that the individual meets other exceptional circumstances as the Exchange may provide;

(10) A qualified individual or enrollee—

(i) Is a victim of domestic abuse or spousal abandonment, including a dependent or unmarried victim within a household, is enrolled in minimum essential coverage and seeks to enroll in coverage separate from the perpetrator of the abuse or abandonment; or

(ii) Is a dependent of a victim of domestic abuse or spousal abandonment, on the same application as the victim, may enroll in coverage at the same time as the victim;

(11) A qualified individual or dependent—

(i) Applies for coverage through NYSOH during the annual open enrollment period or due to a qualifying event, is assessed as potentially eligible for Medicaid or Child Health Plus and is determined ineligible for Medicaid or Child Health Plus either after open enrollment has ended or more than 60 days after the qualifying event; or

(ii) Applies for coverage at their Local Department of Social Services or Human Resources Administration during the annual open enrollment period, and is determined ineligible for Medicaid or Child Health Plus after open enrollment has ended;

(12) The qualified individual or enrollee, or his or her dependent, adequately demonstrates to NYSOH that a material error related to plan benefits, service area, or premium influenced the qualified individual's or enrollee's decision to purchase a qualified health plan; or

(13) At the option of NYSOH, the qualified individual provides satisfactory documentary evidence to verify his or her eligibility for an insurance affordability program or enrollment following termination of enrollment due to a failure to verify such status within 90 days. NYSOH has not elected to adopt this subsection at this time.

(45 CFR § 155.420(d)).

Generally, if a triggering life event occurs, the qualified individual or enrollee has 60 days from the date of a triggering event to select a qualified health plan (45 CFR § 155.420(c)(1)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you and your spouse did not qualify to enroll in a qualified health plan outside of the open enrollment period.

NYSOH provided an open enrollment period from November 1, 2016 until January 31, 2017. On May 13, 2017, you submitted an application for health insurance and requested to enroll in a new qualified health plan. On May 20, 2017, NYSOH issued a notice stating that you and your spouse did not qualify to enroll in a qualified health plan outside of the open enrollment period.

Once the annual open enrollment period ends, a health plan enrollee must qualify for a special enrollment period to enroll in, or change to another health plan offered in NYSOH. To qualify for a special enrollment period, a person must experience a triggering event.

A special enrollment period can be granted if a qualified individual's enrollment or non-enrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities

You testified that on March 20, 2017, while you were selecting a plan for enrollment, that a NYSOH representative did not advise you that there was a difference between the deductible for the Healthfirst silver level qualified health plan and bronze level qualified health plan. You testified that on that date you selected a bronze level qualified health plan for you and your spouse.

You testified that if you had been given accurate information by the NYSOH representative on March 20, 2017 that you would have selected a silver level plan and not a bronze level qualified health plan for you and your spouse.

NYSOH records contain an Incident [REDACTED], dated April 24, 2017, which includes the results of a call pull from March 20, 2017. The notes state that "At 26 minutes 58 seconds into the call, the consumer was provided the price and deductible for the Healthfirst Bronze plan and she stated that she wanted to confirm provider participation. After calling the provider she returned to the line and stated that she would like to select the bronze level plan '100 percent' at 32 minutes 35 seconds."

The above is evidence that NYSOH provided you with accurate information to select a qualified health plan for you and your spouse. As NYSOH records do not indicate that NYSOH, by action or inaction, made an error or misrepresented information, a special enrollment period cannot be granted.

The credible evidence of record indicates that, since the open enrollment period closed on January 31, 2017, no other triggering events have occurred that would qualify you and your spouse for a special enrollment period.

Therefore, NYSOH's May 20, 2017 eligibility determination stating that you and your spouse do not qualify to select a health plan outside of the open enrollment period for 2017 is AFFIRMED.

Decision

The May 20, 2017 eligibility determination is AFFIRMED.

How this Decision Affects Your Eligibility

You and your spouse do not qualify for a special enrollment period at this time.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
