## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were ineligible for the Essential Plan?

Did NYSOH properly determine that you were eligible for Medicaid, effective April 1, 2017?

## Procedural History

On April 28, 2017, you submitted an application for financial assistance.

On April 29, 2017, NYSOH issued a notice stating that the income information in your application did not match what NYSOH had received from state and federal data sources, and that income documentation was due by May 13, 2017 in order to determine your eligibility for financial assistance.

On May 8, 2017, you submitted an updated application for financial assistance.

On May 9, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible for Medicaid, effective April 1, 2017 because your household income was at or below the allowable income limit for that program.

On May 15, 2017, you spoke to NYSOH's Account Review Unit and appealed the determination insofar as you were found eligible for Medicaid and not the Essential Plan.

On August 15, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and left open for fourteen days to allow you to submit documentation of your income.

As of the close of business on August 29, 2017, the Appeals Unit did not receive any documents from you and none were viewable in your NYSOH account. Therefore, the record was closed that same day and this decision is based on the record as developed at the time of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 tax return with a tax filing status of single. You will claim no dependents on that tax return.
- 2) The application that was submitted on May 8, 2017 listed annual household income of \$5,327.00, consisting of \$1,667.30 you earned from employment in 2017, and \$3,660.00 in unemployment insurance benefits. You testified that this amount was incorrect.
- 3) You testified that at the beginning of 2017 you were on a seasonal layoff from your employment and were receiving \$349.00 per week in unemployment insurance benefits. You then worked for one or two weeks in or around March of 2017 and earned approximately \$1,000.00. You then began collecting unemployment insurance benefits again of \$349.00 per week. You testified that your unemployment insurance benefits only recently ended.
- 4) You testified that you have done some [REDACTED] work, but you have not yet received payment for this work.
- 5) You testified that you are in the process of going back to school, and intend to work in a part-time capacity once you know your class schedule, but that you have not yet begun this part-time work.
- 6) You testified that you may be taking deductions on your 2017 tax return, but you are not sure what deductions you will be claiming.
- 7) Your application states, and you confirmed, that you reside in [REDACTED].
- 8) You testified that you are seeking to be found eligible for the Essential Plan as your doctors do not accept Medicaid, and you have been treating

with these doctors for many years and would prefer to keep seeing these doctors.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Fed. Reg. 4036).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

### Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise

eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

## **Legal Analysis**

The first issue under review is whether NYSOH properly determined that you were ineligible for the Essential Plan.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,880.00 for a one-person household. Since an annual household income of \$5,327.00 is 44.84% of the 2016 FPL, NYSOH properly found you to be ineligible for the Essential Plan.

The second issue is whether NYSOH properly determined that you were eligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$12,060.00 for a one-person household. Since \$5,327.00 is 44.17% of the 2017 FPL, NYSOH properly found you to be eligible for Medicaid on an expected annual income basis, using the information provided in your application.

Since the May 9, 2017 eligibility determination properly stated that, based on the information you provided, you were eligible for Medicaid and ineligible for the Essential Plan, it is correct and is **AFFIRMED**.

You testified that the income information in your application was incorrect. You testified that you received approximately \$1,000.00 for working for two weeks in March 2017 and received unemployment insurance of \$349.00 for approximately

30 weeks. Based on the information you provided, your annual gross income is currently \$11,470.00. Since \$11,470.00 is 95.11% of the 2017 FPL, your case will not be returned to NYSOH for a redetermination of your eligibility for financial assistance.

## **Decision**

The May 9, 2017 eligibility determination is **AFFIRMED**.

## **How this Decision Affects Your Eligibility**

You remain eligible for Medicaid.

You are ineligible for the Essential Plan.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
