On May 16, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that your spouse was eligible for the Essential Plan with no monthly premiums and no co pays for certain services and no annual deductible as well as qualified for additional Medicaid benefits, effective June 1, 2017. You appealed this determination.

On July 18, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for August 16, 2017, at 11:00 a.m.

On August 16, 2017, a Hearing Officer placed calls to the number on the notice of hearing [REDACTED] with the aid of [REDACTED] Interpreter [REDACTED] at 11:12, a.m., and again at 11:24 a.m. with [REDACTED] Interpreter [REDACTED] and a third time at your alternate number [REDACTED] with [REDACTED] Interpreter [REDACTED] at 11:35 a.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
