Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your child did not qualify to switch his stand-alone dental plan outside of the open enrollment period, effective July 1, 2017?

Procedural History

On November 18, 2016, NYSOH issued an eligibility determination notice confirming your child's eligibility to enroll in a qualified health plan (QHP) at full cost, effective January 1, 2017.

Also on November 18, 2016, NYSOH issued an enrollment notice confirming your child's enrollment in HDHMO Qualified 44 Bronze HSA NS INN Dep25 Adult Vision Lasik Wellness (HDHMO), as his QHP, and DeltaCare USA Basic Plan for Families NS INN Family Dental Dep 25 (DeltaCare), as his stand-alone dental plan.

On May 17, 2017, NYSOH received your updated application for financial assistance. That day, a preliminary eligibility determination was prepared stating that your child was not eligible for financial assistance. You also attempted to switch your child's enrollment into another stand-alone dental plan, but were unable to do so.

Also on May 17, 2017, you spoke to NYSOH's Account Review Unit and appealed your inability to switch your child's enrollment into a different stand-alone dental plan after the open enrollment period had ended.

On May 18, 2017, NYSOH issued an eligibility determination notice, based on the May 17, 2017 application for financial assistance, stating that your child was eligible to enroll in a QHP at full cost. It further stated that your child did not qualify to select a health plan outside of the open enrollment period for 2017.

On August 24, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) On May 17, 2017, you submitted an update to your application for health insurance.
- 2) On May 17, 2017, you attempted to switch your child's stand-alone dental plan.
- 3) Your application on May 17, 2017 states that you were seeking a special enrollment for your child based on his anticipated end of health coverage, effective May 31, 2017. You testified that this was because you anticipated not paying your child's current stand-alone dental plan premium since it was no longer of value to him.
- 4) You testified you selected the stand-alone dental plan for your child during open enrollment for 2017, but inadvertently picked the wrong plan issued by DeltaCare since there was a minor difference in the plan name.
- 5) You testified that prior to selecting the stand-alone dental plan, you did not take any steps to confirm that your child's dentist accepted the plan you ultimately selected.
- 6) You testified that it was not until mid-May 2017 that you realized that your dentist did not accept the dental plan your child was enrolled in because that was the first time you had made a claim against that policy.
- 7) You testified that since filing your application May 17, 2017 there have been no other major changes to your household.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Enrollment in a Qualified Health Plan

NYSOH must provide annual open enrollment periods during which time qualified individuals may enroll in a qualified health plan and enrollees may change qualified health plans (45 CFR § 155.410(a)(1)).

For the benefit year beginning on January 1, 2017, the annual open enrollment period began on November 1, 2016, and extended through January 31, 2017 (45 CFR § 155.410(e)(2)).

Special Enrollment Periods

After each open enrollment period ends, NYSOH provides special enrollment periods to qualified individuals. During a special enrollment period, a qualified individual may enroll in a qualified health plan, and an enrollee may change their enrollment to another plan. This is generally permitted when one of the following triggering events occur:

- (1) The qualified individual or his or her dependent either:
 - (i) Loses minimum essential coverage.
 - (ii) Is enrolled in any non-calendar year group health plan or individual health insurance coverage, even if the qualified individual or his or her dependent has the option to renew such coverage.
 - (iii) Loses pregnancy-related coverage.
 - (iv) Loses medically needy coverage as described under section 1902(a)(10)(C) of the Social Security Act only once per calendar year.
- (2)(i) The qualified individual gains a dependent or becomes a dependent through marriage, birth, adoption, placement for adoption, or placement in foster care, or through a child support order or other court order.
 - (ii) the enrollee loses a dependent or is no longer considered a dependent through divorce or legal separation as defined by State law in the State in which the divorce or legal separation occurs, or if the enrollee, or his or her dependent, dies.

(3) The qualified individual, or his or her dependent, becomes newly eligible for enrollment in a qualified health plan because he or she gains citizenship, status as a national, or lawful present or is no longer incarcerated.

(4) The qualified individual's or his or her dependent's, enrollment or non-enrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities.

(5) The enrollee or, his or her dependent adequately demonstrates to NYSOH that the qualified health plan in which he or she is enrolled substantially violated a material provision of its contract in relation to the enrollee;

(6) The enrollee or enrollee's dependent is newly eligible or ineligible for advance payments of the premium tax credit, or change in eligibility for cost-sharing reductions.

(7) The qualified individual or enrollee, or his or her dependent, gains access to new qualified health plan as a result of a permanent move and either—

(i) Had minimum essential coverage for one or more days during the 60 days preceding the date of the permanent move, or

(ii) Was living outside of the United States or in a United States territory at the time of the permanent move;

(8) The qualified individual or dependent who gains or maintains status as an Indian may enroll in a qualified health plan or change from one plan to another, once per month.

(9) The qualified individual or enrollee, or his or her dependent, demonstrates to the Exchange, in accordance with guidelines issued by HHS, that the individual meets other exceptional circumstances as the Exchange may provide;

(10) A qualified individual or enrollee—

(i) Is a victim of domestic abuse or spousal abandonment, including a dependent or unmarried victim within a household, is enrolled in

minimum essential coverage and seeks to enroll in coverage separate from the perpetrator of the abuse or abandonment; or

(ii) Is a dependent of a victim of domestic abuse or spousal abandonment, on the same application as the victim, may enroll in coverage at the same time as the victim;

(11) A qualified individual or dependent—

(i) Applies for coverage through NYSOH during the annual open enrollment period or due to a qualifying event, is assessed as potentially eligible for Medicaid or Child Health Plus and is determined ineligible for Medicaid or Child Health Plus either after open enrollment has ended or more than 60 days after the qualifying event; or

(ii) Applies for coverage at their Local Department of Social Services or Human Resources Administration during the annual open enrollment period, and is determined ineligible for Medicaid or Child Health Plus after open enrollment has ended;

(12) The qualified individual or enrollee, or his or her dependent, adequately demonstrates to NYSOH that a material error related to plan benefits, service area, or premium influenced the qualified individual's or enrollee's decision to purchase a qualified health plan; or

(13) At the option of NYSOH, the qualified individual provides satisfactory documentary evidence to verify his or her eligibility for an insurance affordability program or enrollment following termination of enrollment due to a failure to verify such status within 90 days. NYSOH has not elected to adopt this subsection at this time.

(45 CFR § 155.420(d)).

Generally, if a triggering life event occurs, the qualified individual or enrollee has 60 days from the date of a triggering event to select a qualified health plan (45 CFR § 155.420(c)(1)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your child did not qualify to switch his stand-alone dental plan outside of the open enrollment period, effective July 1, 2017.

NYSOH provided an open enrollment period from November 1, 2016 until January 31, 2017. On May 17, 2017, you submitted an updated application for health insurance and requested to switch your child's stand-alone dental plan to another plan accepted by his dentist. On May 18, 2017, NYSOH issued a notice stating that you do not qualify to enroll in a qualified health plan outside of the open enrollment period.

Once the annual open enrollment period ends, a health plan enrollee must qualify for a special enrollment period in order to enroll in, or change to another health plan offered in NYSOH. In order to qualify for a special enrollment period, a person must experience a triggering event.

A special enrollment period can be granted if a qualified individual's enrollment or non-enrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities

You testified you selected a DeltaCare stand-alone dental plan for your child during open enrollment for 2017, but inadvertently picked the wrong plan issued by DeltaCare since there was a minor difference in the plan name. You further testified that prior to selecting this stand-alone dental plan, you did not take any steps to confirm that your child's dentist accepted the plan you ultimately selected.

Since the record does not indicate that NYSOH, by action or inaction, made an error or misrepresented information, a special enrollment period cannot be granted.

Furthermore, even if your child did lose his dental coverage as a result of non-payment of premium, the loss of health insurance coverage in this case cannot be considered a triggering event for a special enrollment period, because it was a result of non-payment of your premiums which NYSOH considers a voluntary action causing the termination of your coverage.

The credible evidence of record indicates that, since the open enrollment period closed on January 31, 2017, no other triggering events have occurred that would qualify your child for a special enrollment period.

Therefore, NYSOH's May 18, 2017 eligibility determination that your child does not qualify to select or change a health plan outside of the open enrollment period for 2017 is **AFFIRMED**.

Decision

The May 18, 2017 eligibility determination is AFFIRMED.

How this Decision Affects Your Eligibility

Your child does not qualify for a special enrollment period at this time.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
