## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your enrollment in your Medicaid Managed Care plan with Healthfirst was effective July 1, 2017?

## Procedural History

On February 28, 2017, NY State of Health (NYSOH) received your application for financial assistance with health insurance.

On March 1, 2017, NYSOH issued an eligibility determination stating that you were eligible for Medicaid, effective March 1, 2017.

On March 1, 2017, NYSOH issued a plan enrollment notice confirming your enrollment in a Medicaid Managed Care plan with Empire Blue Cross Blue Shield, effective April 1, 2017.

On May 24, 2017, NYSOH received your updated application for financial assistance with health insurance. A preliminary determination was issued that day stating that you remained eligible for Medicaid. You also enrolled into a Medicaid Managed Care plan with Healthfirst that day.

Also on May 24, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your Medicaid Managed Care plan with Healthfirst insofar as it did not begin on April 1, 2017.

On May 25, 2017, NYSOH issued a notice of eligibility determination, based on your May 24, 2017 application, stating that you remained eligible for Medicaid, effective July 1, 2017.

Also on May 25, 2017, NYSOH issued a notice of enrollment in the plan you selected on May 24, 2017, stating that you were enrolled in a Medicaid Managed Care plan with Healthfirst, and that your coverage would start on July 1, 2017.

On September 8, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on February 28, 2017.
- 2) On February 28, 2017, you selected a Medicaid Managed Care plan with Empire Blue Cross Blue Shield for enrollment, and that coverage was effective April 1, 2017.
- 3) You testified that after several visits to your doctor's office, you were informed that they did not accept Empire Blue Cross Blue Shield.
- 4) You testified, and the record reflects, that you selected a Medicaid Managed Care plan with Healthfirst on May 24, 2017, and that your enrollment was effective July 1, 2017.
- 5) You testified that the first time you contacted NYSOH to change your enrollment in your Medicaid Managed Care plan was on May 24, 2017.
- 6) You testified that you want your Medicaid Managed Care plan with Healthfirst to begin as of April 1, 2017 because your doctor does not accept Empire Blue Cross Blue Shield.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

## **Legal Analysis**

The issue is whether NYSOH properly determined that your enrollment in the Medicaid Managed Care plan with Healthfirst was effective July 1, 2017.

You testified that you contacted NYSOH on May 24, 2017 to change your enrollment to from Empire Blue Cross Blue Shield to Healthfirst after being told that your doctor did not accept Empire Blue Cross Blue Shield.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On May 24, 2017, you selected a Medicaid Managed Care plan with Healthfirst for enrollment, so it properly took effect on the first day of the second month following after May 2017; that is, on July 1, 2017.

Therefore, the May 25, 2017 plan enrollment notice stating that your enrollment in your Medicaid Managed Care plan with Healthfirst would be effective July 1, 2017, was correct and must be AFFIRMED.

## **Decision**

The May 25, 2017 plan enrollment notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your eligibility.

The effective date of your Medicaid Managed Care plan with Healthfirst is July 1, 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
