## **NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL**

On May 18, 2017, NY State of Health (NYSOH) issued a plan enrollment notice, stating that you and your spouse were enrolled in a Medicaid Managed Care plan, effective July 1, 2017. You appealed that determination.

On August 29, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because your medical expenses were covered by Medicaid Fee-For Service.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

### **How does this Dismissal Affect Your Eligibility?**

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.
