## NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On May 14, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that your child was no longer eligible for health insurance through NYSOH, effective June 1, 2017. You appealed that determination.

On August 24, 2017, a Hearing Officer from the Appeals Unit of NYSOH called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because your child's Child Health Plus plan coverage had been reinstated as of July 1, 2017, and you had not incurred out-of-pocket costs exceeding the \$60.00 premium amount that would be due if your child's coverage was reinstated during the month June 2017.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

### How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
