NOTICE OF DISMISSAL – FAILURE TO APPEAR

On May 27, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible for the Essential Plan with a \$20.00 premium responsibility per month, effective July 1, 2017. You appealed this determination.

On July 26, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for August 14, 2017, at 9:00 a.m.

On August 14, 2017, a Hearing Officer contacted you. While under oath you testified, you would be unable to go forward with the hearing at that time as a personal issue came up that kept you from contacting your Broker to notify him that you wanted him to appear at your hearing. The Hearing Officer granted you an adjournment until Thursday August, 24, 2017 at 9:00 a.m. You agreed to waive formal notice to a telephone hearing at that time.

On August 24, 2017, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 9:00 a.m., 9:15 a.m., and 9:30 a.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
