## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your eligibility for and enrollment in an Essential Plan was effective July 1, 2017?

## Procedural History

On May 18, 2017, NYSOH received your initial application for health insurance.

On May 19, 2017, NYSOH issued a notice of eligibility determination, based on your May 18, 2017 application, stating that you were conditionally eligible to enroll in the Essential Plan, effective July 1, 2017. You were requested to provide income documentation by August 16, 2017 to confirm your eligibility.

Also on May 19, 2017, NYSOH issued an enrollment notice, based on your plan selection on May 18, 2017, stating that you were enrolled in an Essential Plan, and that your plan would start July 1, 2017.

On May 30, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in the Essential insofar as it did not begin June 1, 2017.

On June 15, 2017, NYSOH received (1) Social Security Administration notices of award reflecting your entitlement to benefits beginning January 2017, (2) a direct deposit summary of pension income you receive from [REDACTED] and (3) a letter

issued to you by [REDACTED], dated May 11, 2017, stating that your health insurance coverage would end effective May 31, 2017.

Also on June 15, 2017, NYSOH redetermined your eligibility for health insurance.

On June 16, 2017, NYSOH issued an eligibility redetermination notice stating that you were eligible for the Essential Plan, without condition, effective July 1, 2017.

On August 31, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You submitted your initial application to NYSOH for financial assistance on May 18, 2017.
- 2) You testified, and your NYSOH account reflects, that you enrolled in an Essential Plan on May 18, 2017.
- 3) You testified, and provided documentation reflecting, that your employer-sponsored insurance coverage ended effective May 31, 2017.
- 4) You testified that you spoke to several representatives from NYSOH who indicated that your Essential Plan coverage could and would be backdated to June 1, 2017.
- 5) You testified that on or about June 15, 2017, you spoke to a different NYSOH representative who stated that your Essential Plan coverage could not be backdated to June 1, 2017 because you had not timely provided your income documentation as requested under the May 19, 2017 eligibility determination notice.
- 6) You testified that you wanted your enrollment in the Essential Plan to begin on June 1, 2017, rather than July 1, 2017, because you had received conflicting statements from several NYSOH representative on whether your coverage would be backdated to June 1, 2017.
- 7) You testified that you incurred no out-of-pocket medical expenses as a result of not having had Essential Plan coverage during the month of June 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

## **Legal Analysis**

The issue is whether NYSOH properly determined that your eligibility for and enrollment in the Essential Plan was effective July 1, 2017.

You testified, and the record indicates, that you submitted your initial NYSOH application on May 18, 2017. As a result, you were found eligible for the Essential Plan as of May 18, 2017, and enrolled into a plan that day.

You testified that you spoke to several representatives from NYSOH who indicated that your Essential Plan coverage could begin effective June 1, 2017.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On May 18, 2017, you selected an Essential Plan, so your enrollment properly took effect on the first day of the second month following May 2017; that is, on July 1, 2017.

Therefore, the May 19, 2017 eligibility determination and enrollment notices stating that your eligibility for and enrollment in the Essential Plan was effective July 1, 2017, are correct and must be AFFIRMED.

## **Decision**

The May 19, 2017 eligibility determination and enrollment notices are AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your eligibility.

The effective date of your Essential Plan coverage is July 1, 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
