Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in an Essential Plan was effective July 1, 2017?

Procedural History

On May 16, 2017, NYSOH issued a notice of eligibility determination, based on your May 15, 2017 application, stating that you were eligible to enroll in the Essential Plan, effective June 1, 2017. This notice advised to you to select a health plan, and that you would receive written confirmation from NYSOH once you have selected a plan.

On May 25, 2017, NYSOH received an update to your application for health insurance.

On May 26, 2017, NYSOH issued an eligibility redetermination notice, based on your May 25, 2017 application, stating that you were eligible to enroll in the Essential Plan, effective July 1, 2017.

Also on May 26, 2017, NYSOH issued a notice of enrollment, based on your plan selection on May 25, 2017, stating that you were enrolled in an Essential Plan, and that your plan would start July 1, 2017.

On June 2, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in the Essential Plan insofar as it did not begin June 1, 2017.

On August 31, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted your initial application to NYSOH for financial assistance on May 15, 2017.
- 2) You testified, and your NYSOH account reflects, that you enrolled in an Essential Plan on May 25, 2017.
- 3) You testified that you inadvertently did not select a plan when you had completed your initial application on May 15, 2017. You further testified that you did not realize that you had yet to select a plan until you received the May 16, 2017 eligibility determination notice directing you to select a health plan so that your coverage could begin.
- 4) You testified that you wanted your enrollment in an Essential Plan to begin on June 1, 2017 because you had incurred out-of-pocket expenses from filling two prescriptions and a doctor's appointment.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible

for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue is whether NYSOH properly determined that your enrollment in the Essential Plan was effective July 1, 2017.

You testified, and the record indicates, that you submitted your initial NYSOH application on May 15, 2017. As a result, you were found eligible for the Essential Plan as of May 15, 2017. However, you testified, and your NYSOH account reflects, that you did not enroll in a plan at that time, but rather several days later on May 25, 2017.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On May 25, 2017, you selected an Essential Plan, so your enrollment properly took effect on the first day of the second month following May 2017; that is, on July 1, 2017.

Therefore, the May 26, 2017 enrollment notice stating that your enrollment in the Essential Plan was effective July 1, 2017, is correct and must be AFFIRMED.

Decision

The May 26, 2017 enrollment notice is AFFIRMED.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
