Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible to receive up to \$120.00 per month in advance payments of the premium tax credit for a limited time, effective July 1, 2017?

Did NYSOH properly determine that you were not eligible for cost-sharing reductions?

Did NYSOH properly determine that you were not eligible for the Essential Plan?

Procedural History

On June 5, 2017, you submitted an application for financial assistance. That day, a preliminary eligibility determination was prepared stating that you were eligible for an advance premium tax credit (APTC) of up \$120.00 per month for a limited time, effective July 1, 2017. The notice further stated that you must submit documents to confirm that the information you provided in your application is accurate.

Also on June 5, 2017, you spoke to NYSOH's Account Review Unit and appealed insofar as you were found eligible for APTC, rather than the Essential Plan. You were found eligible for "Aid to Continue" during the pendency of the appeal, so you were reenrolled in the Essential Plan for a limited time.

On June 6, 2017, NYSOH issued a notice of eligibility determination notice stating that you were eligible to receive an advance premium tax credit (APTC) of up to \$120.00 for a limited time, effective July 1, 2017. You were requested to provide proof of your income by August 24, 2017 to confirm your eligibility. That notice also stated that you were not eligible for either cost-sharing reductions (CSR) or the Essential Plan because your income was over the allowable income limits for that programs.

Also on June 6, 2017, NYSOH issued an enrollment notice confirming your selection of a silver-level health plan as of June 5, 2017. The notice stated that your coverage under this plan would begin effective July 1, 2017.

On September 8, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of married filing jointly. You will claim no dependents on that tax return.
- 2) You are seeking insurance for yourself only.
- 3) The application that was submitted on June 5, 2017 listed annual household income of \$44,640.00, consisting of \$2,800.00 per month your spouse expects to earn from his employment with \$920.00 per month you expect to earn from your business. You testified that these amounts were correct at the time you submitted your application on June 5, 2017.
- 4) Your application states that you will not be taking any deductions on your 2017 tax return.
- 5) You live in , New York.
- 6) You testified that during March 2017, you and your spouse physically separated, but remain legally married as no separation agreement or divorce decree has yet been sought or issued. You testified that you and your spouse now live at different addresses as reflected in your June 5, 2017 application.

7) You testified that you were seeking to be found eligible for the Essential Plan, rather than eligible for APTC, since health plans through NYSOH are unaffordable even after applying the maximum APTC.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Advance Payments of Premium Tax Credit

Advance payments of the premium tax credit (APTC) are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

 the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2017 is set by federal law at 2.04% to 9.69% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3T(g)(1), IRS Rev. Proc.2016-24).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2016 FPL, which is \$16,020 for a two-person household (81 Federal Register 4036).

For annual household income in the range of at least 250% but less than 300% of the 2016 FPL, the expected contribution is between 8.21% and 9.69% of the

household income (26 CFR § 1.36B-3T(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2016-24).

People who use the APTC to help pay health insurance premiums must file a federal tax return and reconcile their expected income (stated on NYSOH application) with their actual income (stated on their federal income tax return). Those who take less tax credit in advance than they claim on the tax return may get the rest of it as an income tax refund or have their tax bill reduced. Those who take more tax credit in advance than they can claim on their tax return will owe the difference as additional income taxes (26 CFR § 1.36B-4).

Cost-Sharing Reductions

Cost-sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present noncitizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$16,020.00 for a two-person household (81 Fed. Reg. 4036).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see https://www.medicaid.gov/basic-health-program.html).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

Legal Analysis

The first issue is whether NYSOH properly determined that you eligible for an APTC of up to \$120.00 per month, effective July 1, 2017.

The application that was submitted on June 5, 2017 listed an annual household income of \$44,640.00, which was comprised of \$33,600 (\$2,800.00 x 12 months) your spouse expects to earn from his employment with \$11,040.00 (\$920.00 x 12 months) you expect to earn from your business. The eligibility determination relied upon that information.

You are in a two-person household. You expect to file your 2017 income taxes as married filing jointly and will claim no dependents on that tax return.

You reside in where the second lowest cost silver plan available for an individual through NYSOH costs \$456.46 per month.

An annual income of \$44,640.00 is 278.65% of the 2016 FPL for a two-person household. At 278.65% of the FPL, the expected contribution to the cost of the health insurance premium is 9.06% of income, or \$336.96 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual in your county (\$456.46 per month) minus your expected contribution (\$336.96 per month), which equals \$119.50 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you to be eligible for up to \$120.00 per month in APTC.

The second issue is whether you were properly found not eligible for CSR.

CSR is available to a person who has a household income no greater than 250% of the FPL. Since a household income of \$44,640.00 is 278.65% of the applicable FPL, NYSOH correctly found you to be not eligible for CSR.

The third issue under review is whether NYSOH properly determined that you were eligible for the Essential Plan.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$16,020.00 for a two-person

household. Since an annual household income of \$44,640.00 is 278.65% of the 2016 FPL, NYSOH properly found you to be ineligible for the Essential Plan.

Since the June 6, 2017 eligibility determination notice properly stated that, based on the information you provided, you were eligible for up to \$120.00 per month in APTC, not eligible for CSR, and not eligible for the Essential Plan, it is correct and is AFFIRMED.

Decision

The June 6, 2017 eligibility determination notice is AFFIRMED.

Your case is RETURNED to NYSOH to assist you in enrolling a plan for which you are eligible.

How this Decision Affects Your Eligibility

You remain eligible for an APTC of up to \$120.00 per month.

You are not eligible for CSR.

You are not eligible for the Essential Plan, and your limited enrollment in that coverage will end.

You case is returned to NYSOH to assist you in enrolling a plan for which you are eligible.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be

appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
