NOTICE OF DISMISSAL – FAILURE TO APPEAR

On June 7, 2017, NY State of Health (NYSOH) issued a notice of enrollment confirmation, stating that your child was enrolled in her Child Health Plus plan, effective July 1, 2017. You appealed this determination.

On August 11, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for September 7, 2017, at 11:00 am.

On September 7, 2017, a Hearing Officer placed one call to you at 11:00 am. Although you answered, you requested that day that the hearing be adjourned to a later date. The hearing was adjourned to September 13, 2017 at 11:00 am.

On September 13, 2017, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 11:00 am, 11:15 am, and 11:30 am, but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
