Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were not eligible for Medicaid from April 1, 2017 through April 30, 2017?

Procedural History

On May 23, 2017, you submitted an updated application for financial assistance and indicated that you were seeking help for paying for medical bills for April 2017.

On June 6, 2017, you spoke to NYSOH's Account Review Unit and appealed insofar as you were denied retroactive Medicaid for the month of April 2017.

On June 27, 2017, NYSOH issued an eligibility determination notice stating that you were not eligible for Medicaid for April 1, 2017 through April 30, 2017 because the monthly household income of \$1,716.00 is over the allowable monthly income limit of \$1,387.00.

On September 15, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing held open up to October 2, 2017, to allow you to submit supporting documents for your income for the month of April 2017.

As of October 2, 2017, the Appeals Unit did not receive any documents from you and none were viewable in your NYSOH account. Therefore, the record was

closed that same day and this decision is based on the record as developed at the time of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking Medicaid for the month of April 2017.
- 2) You testified that you expect to file your 2017 federal income tax return as single, and claim no dependents.
- 3) You testified that you do not plan on taking any deductions on your tax return.
- 4) You submitted an updated application for financial assistance on May 23, 2017.
- 5) Your application submitted on May 23, 2017, states that for the month of April 2017 your income was \$1,716.00. You testified that amount was incorrect.
- 6) You testified that you are paid bi-weekly and earn \$11.00 per hour and your hours vary each week.
- 7) You testified that your gross pay for check dated April 7, 2017 was \$532.78 and your gross pay for check dated April 21, 2017 was \$842.87 for a total income in April 2017 of \$1,375.65. However, you did not upload or submit via secure facsimile copies of those two paychecks by the October 2, 2017 deadline set by the Hearing Officer.
- 8) You testified that you were seen in a [REDACTED] in April 2017, and had follow up care with [REDACTED] treatment in April 2017.
- 9) You testified that you need retroactive Medicaid for the month of April 2017 because of the uncovered expenses related to your [REDACTED] [REDACTED] visits in that month.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid for Adults between the Ages of 19 and 65

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Fed. Reg. 8831).

Retroactive Medicaid

The Department of Health must make Medicaid coverage start retroactively for up to three months prior to the month of an initial application if the individual received medical services that would have been covered under Medicaid and the individual would have been eligible for Medicaid at the time he received the services if he had applied (42 USCA § 1396A(34); 42 CFR § 435.915(a)). The Department of Health may make eligibility effective for fee-for-service Medicaid on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you were not eligible for Medicaid from April 1, 2017 through April 30, 2017.

You are in a one-person household; you file your taxes with a tax filing status of single and claim no dependents on your tax return.

You submitted an updated application for financial assistance on May 23, 2017 and requested help in paying for medical bills for April 2017.

When an individual files an initial application for Medicaid, his or her eligibility for retroactive Medicaid depends on the date of application. To this end, it does not matter whether or not that initial application resulted in Medicaid going forward. Instead, an individual, who has filed an initial application for Medicaid through

NYSOH, has the right to be evaluated for Medicaid for the three months before the month of his or her application.

Medicaid coverage can be made effective retroactively for up to three months prior to an individual's initial application if the individual received medical services that would have been covered under Medicaid and if they would have been eligible for Medicaid in those three months had they applied.

You testified that you are seeking Medicaid from April 1, 2017 to April 30, 2017 because you have uncovered expenses related to your [REDACTED] from April 2017.

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size. To be eligible for Medicaid in April 2017, you would have needed to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,387.00 per month. There is no indication in the record that you would have been ineligible for Medicaid based on non-financial criteria during April 2017.

You testified that you are paid bi-weekly. The application that was submitted on May 23, 2017 indicates that your income in the month of April 2017 was \$1,716.00 and NYSOH relied on that when determining your eligibility for retroactive Medicaid for the month of April 2017. You testified at the hearing that you had two paychecks in the month of April 2017. The April 7, 2017 paycheck had gross pay of \$532.78 and the April 21, 2017 paycheck had gross pay of \$842.87 for a total income for April 2017 of \$1,375.65. The Hearing Officer allowed you up to October 2, 2017 to submit proof of those paychecks either by uploading them to your account or by submitting them via secure facsimile to the NYSOH Appeals Unit. As of October 2, 2017, no documents were received and the record closed as of that date. Therefore, the record indicates that in the month of April 2017, you had a monthly household income of \$1,716.00.

Since your income of \$1,716.00 was more than the \$1,387.00 monthly Medicaid limit for April 2017, NYSOH properly determined that you were not eligible for Medicaid coverage during that month.

Therefore, the June 27, 2017 eligibility determination notice stating that you were not eligible for Medicaid in the month of April 2017 because your income of \$1,716.00 is over the allowable amount of \$1,387.00 is correct and is **AFFIRMED**.

This decision does not affect any subsequent eligibility determination notices issued by NYSOH.

Decision

The June 27, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You were not eligible for Medicaid in the month of April 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
