NOTICE OF DISMISSAL

On May 4, 2017, NY State of Health (NYSOH) issued a renewal notice containing an eligibility determination stating that you qualified for a tax credit of up to \$277.29 per month to help pay for your health coverage and could also receive help with cost sharing reductions if you enrolled in a silver level qualified health plan, effective July 1, 2017. On June 12, 2017, you appealed this determination. On July 20, 2017, NYSOH granted your request for aid to continue and you were re-enrolled in your Medicaid Managed Care plan pending the outcome of your appeal.

On August 14, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for September 8, 2017 at 11:00 a.m. On September 8, 2017, the Hearing Officer placed three calls to the telephone number that you provided to NYSOH, but was unable to reach you. You contacted NYSOH on September 8, 2017 and stated that your phone reception was going in and out and you could not receive the Hearing Officer's calls. The Hearing Officer returned your case to NYSOH to reschedule a new hearing date and time.

On September 11, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was rescheduled for October 10, 2017 at 10:00 a.m. On October 10, 2017 at 10:00 a.m. the Hearing Officer called for the rescheduled hearing and was unable to reach you. At 10:10 a.m. the Hearing Officer called again and did reach you. At that time, the Hearing Officer began the telephone

hearing and you were sworn in and identified yourself. During the process of covering the procedural matters for the hearing, you interrupted the Hearing Officer several times and then asked for a supervisor. The Hearing Officer stated he would seek a Supervising Hearing Officer and stated you would be placed on hold. The Hearing Officer confirmed your phone number in case there was a disconnection. When the hearing officer returned with a Supervising Hearing Officer, your call had been disconnected. The Supervising Hearing Officer called you at 10:22 a.m. and left a message that you would be called again at 10:30 a.m. At 10:30 a.m., the Hearing Officer called and was not able to reach you.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
