## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible to receive up to \$262.00 per month in advance payments of the premium tax credit (APTC), effective May 1, 2017?

Did NYSOH properly determine you were eligible for cost-sharing reductions?

Did NYSOH properly determine that you were not eligible for the Essential Plan?

## **Procedural History**

On January 30, 2017, you submitted an updated application for financial assistance.

On January 31, 2017 NYSOH issued a notice of eligibility determination stating that you were eligible for the Essential Plan with no monthly premium for a limited time, effective March 1, 2017. The notice directed you to submit documentation of your household income by April 30, 2017.

Also on January 31, 2017, NYSOH issued a notice of enrollment confirmation, confirming your enrollment in an Essential Plan with no monthly premium, beginning March 1, 2017.

On April 10, 2017, you faxed documentation to NYSOH.

On April 14, 2017, NYSOH verified the documentation you submitted and updated your application for financial assistance.

On April 15, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to receive up to \$262.00 per month in APTC, and eligible to receive cost-sharing reductions if you enrolled in a silver level qualified health plan, effective May 1, 2017. That notice also stated that you were not eligible for the Essential Plan because your income was over the allowable income limits for that programs. The notice stated that you had until June 13, 2017 to enroll in a qualified health plan.

Also on April 15, 2017, NYSOH issued a disenrollment notice, stating that your enrollment in your Essential Plan was ending as of April 30, 2017 because you were no longer eligible to enroll in the Essential Plan.

On June 17, 2017, you spoke to NYSOH's Account Review Unit and appealed the termination of your Essential Plan coverage as of April 30, 2017.

On September 11, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

# **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of single. You will claim no dependents on that tax return.
- 2) On April 10, 2017, you faxed four weekly paystubs to NYSOH with pay dates of March 7, March 14, March 21, and March 28, 2017. Each paystub showed gross earnings of \$560.00 (Document **Construction**).
- 3) Based on the paystubs you submitted, NYSOH calculated your expected annual income to be \$29,120.00. You testified that this amount was correct.
- 4) Your application states that you will not be taking any deductions on your 2017 tax return.
- 5) Your application states that you live in

- 6) You testified that you did not receive either of the April 15, 2017 notices, and that you did not know that your Essential Plan coverage had ended until you went to the doctor.
- 7) You testified, and your NYSOH account confirms, that you receive notices from NYSOH by regular mail.
- 8) No notices sent to the mailing address on file in April 2017 have been returned to NYSOH as undeliverable.
- 9) You testified that are looking to be re-enrolled into Essential Plan coverage.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

# **Applicable Law and Regulations**

## Advance Payments of Premium Tax Credit

APTC are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

 the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2017 is set by federal law at 2.04% to 9.69% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3T(g)(1), IRS Rev. Proc.2016-24).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Federal Register 4036).

For annual household income in the range of at least 200% but less than 250% of the 2016 FPL, the expected contribution is between 6.43% and 8.21% of the household income (26 CFR § 1.36B-3T(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2016-24).

People who use the APTC to help pay health insurance premiums must file a federal tax return and reconcile their expected income (stated on NYSOH application) with their actual income (stated on their federal income tax return). Those who take less tax credit in advance than they claim on the tax return may get the rest of it as an income tax refund or have their tax bill reduced. Those who take more tax credit in advance than they can claim on their tax return will owe the difference as additional income taxes (26 CFR § 1.36B-4).

## **Cost-Sharing Reductions**

Cost-sharing reductions are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

## Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable FPL or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Fed. Reg. 4036).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see https://www.medicaid.gov/basic-health-program.html).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

# Legal Analysis

The first issue under review is whether NYSOH properly determined that you were eligible for up to \$262.00 per month in APTC.

You submitted paystubs on April 10, 2017, and NYSOH utilized those paystubs to determine that your expected gross annual income is \$29,120.00. You confirmed in your testimony that this amount is correct. The April 15, 2017 eligibility determination relied upon that information.

You are in a one-person household. You expect to file your 2017 income taxes as single and will claim no dependents on that tax return.

You reside in Queens County, where the second lowest cost silver plan available for an individual through NYSOH costs \$456.46 per month.

An annual income of \$29,120.00 is 245.12% of the 2016 FPL for a one-person household. At 245.12% of the FPL, the expected contribution to the cost of the health insurance premium is 8.04% of income, or \$195.10 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual in your county (\$456.46 per month) minus your expected contribution (\$195.10 per month), which equals \$261.36 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you to be eligible for up to \$262.00 per month in APTC.

The second issue under review is whether you were properly found eligible for cost-sharing reductions. Cost-sharing reductions are available to a person who has a household income no greater than 250% of the FPL. Since a household

income of \$29,120.00 is 245.12% of the applicable FPL, NYSOH correctly found you to be eligible for cost sharing reductions.

The third issue under review is whether NYSOH properly determined that you were ineligible for the Essential Plan, as of April 14, 2017.

The Essential Plan is provided through NYSOH to individuals who meet the nonfinancial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,880.00 for a one-person household. Since an annual household income of \$29,120.00 is 245.12% of the 2016 FPL, NYSOH properly found you to be ineligible for the Essential Plan.

Since the April 15, 2017 eligibility determination properly stated that, based on the information you provided, you were eligible for up to \$262.00 per month in APTC, eligible for cost-sharing reductions, and ineligible for the Essential Plan, it is correct and is AFFIRMED.

Though you testified at the hearing that you did not receive the April 15, 2017 eligibility determination or disenrollment notice, and did not know that your Essential Plan coverage had ended, none of the notices issued to you in April 2017 were returned to NYSOH as undeliverable. Additionally, your receipt of the notices is not relevant to the issue of your underlying eligibility for financial assistance.

# Decision

The April 15, 2017 eligibility determination notice is AFFIRMED.

# How this Decision Affects Your Eligibility

You remain eligible for up to \$262.00 in APTC.

You are eligible for cost-sharing reductions.

You are ineligible for the Essential Plan.

# If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
