#### Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Was your qualified health plan (QHP) properly cancelled for non-payment of premiums?

Did NY State of Health (NYSOH) properly determine that you did not qualify to enroll in a QHP outside of the open enrollment period?

## **Procedural History**

On December 16, 2016, NYSOH issued an eligibility determination notice stating in part that you were eligible for a tax credit up to \$127.00 per month, effective January 1, 2017.

Also on December 16, 2016, NYSOH issued a plan enrollment notice confirming in part that your coverage with a QHP would not begin until you selected a plan.

On January 5, 2017, NYSOH issued a plan enrollment notice confirming in part that, as of January 4, 2017, you were enrolled in a QHP with an enrollment start date of February 1, 2017.

On February 3, 2017, NYSOH issued a disenrollment notice stating that your QHP coverage would end on January 1, 2017, because you did not pay your insurance bill by the payment deadline.

On March 31, 2017, NYSOH issued a plan enrollment notice confirming in part that you did not qualify to select a health plan outside of the open enrollment period for 2017.

On June 22, 2017, you spoke to NYSOH's Account Review Unit and requested an appeal insofar as your QHP was terminated and your eligibility for a special enrollment period was denied.

On July 25, 2017, you faxed to NYSOH a request for an expedited hearing (see Documents ).

On July 28, 2017, NYSOH issued a notice stating that your request for an expedited hearing had been denied (see Document).

On September 18, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that your appeal is only regarding your health insurance coverage.
- 2) You testified that you are seeking to be enrolled in a health plan, prospectively.
- 3) According to your NYSOH account, you enrolled in an Oscar bronze-level QHP on January 4, 2017.
- 4) On January 5, 2017, NYSOH issued you an enrollment notice confirming that your QHP enrollment start date was February 1, 2017 (see Document).
- 5) You testified that you received the January 5, 2017 plan enrollment notice. Based on that notice, you contacted NYSOH and requested that your QHP have an enrollment start date of January 1, 2017.
- 6) You testified that you had a medical appointment on however, they refused to see you because the medical office's system reflected that you were not enrolled in health insurance.
- 7) According to the enrollment history in your account, your QHP enrollment start date was changed to January 1, 2017, on January 24, 2017.

- 8) You testified that you were notified by NYSOH at the end of January 2017, that your request to change your enrollment start date to January 1, 2017, was granted.
- 9) You testified that you did not pay the January 2017 health insurance premium because the month was almost over.
- According to your NYSOH account, on February 2, 2017, the health plan initiated termination of your coverage for nonpayment of the January 2017 monthly premium.
- 11) You testified that you received a notice from the health plan at the end of February 2017 directing you to pay the March 2017 premium. Based on that notice, you submitted payment to the health plan.
- 12) You testified you were contacted by an Oscar representative in April 2017, and were informed that the payment submitted was applied to the January 2017 premium.
- 13) You testified that since filing your application on December 15, 2016, there have been no other major changes to your household.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

#### Appealable Issues

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) an eligibility determination for an exemption; (4) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR § 155.505; and (5) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

#### Enrollment in a Qualified Health Plan

NYSOH must provide annual open enrollment periods during which time qualified individuals may enroll in a qualified health plan and enrollees may change qualified health plans (45 CFR § 155.410(a)(1)).

For the benefit year beginning on January 1, 2017, the annual open enrollment period began on November 1, 2016, and extended through January 31, 2017 (45 CFR § 155.410(e)(2)).

#### **Special Enrollment Periods**

After each open enrollment period ends, NYSOH provides special enrollment periods to qualified individuals. During a special enrollment period, a qualified individual may enroll in a qualified health plan, and an enrollee may change their enrollment to another plan. This is generally permitted when one of the following triggering events occur:

- (1) The qualified individual or his or her dependent either:
  - (i) Loses minimum essential coverage.
  - (ii) Is enrolled in any non-calendar year group health plan or individual health insurance coverage, even if the qualified individual or his or her dependent has the option to renew such coverage.
  - (iii) Loses pregnancy-related coverage.
  - (iv) Loses medically needy coverage as described under section 1902(a)(10)(C) of the Social Security Act only once per calendar year.
- (2) The qualified individual gains a dependent or becomes a dependent through marriage, birth, adoption, placement for adoption, or placement in foster care, or through a child support order or other court order.
  - (ii) the enrollee loses a dependent or is no longer considered a dependent through divorce or legal separation as defined by State law in the State in which the divorce or legal separation occurs, or if the enrollee, or his or her dependent, dies.
- (3) The qualified individual, or his or her dependent, becomes newly eligible for enrollment in a qualified health plan because he or she gains citizenship, status as a national, or lawful present or is no longer incarcerated.
- (4) The qualified individual's or his or her dependent's, enrollment or nonenrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities.

- (5) The enrollee or, his or her dependent adequately demonstrates to NYSOH that the qualified health plan in which he or she is enrolled substantially violated a material provision of its contract in relation to the enrollee;
- (6) The enrollee or enrollee's dependent is newly eligible or ineligible for advance payments of the premium tax credit, or change in eligibility for cost-sharing reductions.
- (7) The qualified individual or enrollee, or his or her dependent, gains access to new qualified health plan as a result of a permanent move and either—
  - (i) Had minimum essential coverage for one or more days during the 60 days preceding the date of the permanent move, or
  - (ii) Was living outside of the United States or in a United States territory at the time of the permanent move;
- (8) The qualified individual or dependent who gains or maintains status as an Indian may enroll in a qualified health plan or change from one plan to another, once per month.
- (9) The qualified individual or enrollee, or his or her dependent, demonstrates to the Exchange, in accordance with guidelines issued by HHS, that the individual meets other exceptional circumstances as the Exchange may provide;
- (10) A qualified individual or enrollee—
  - (i) Is a victim of domestic abuse or spousal abandonment, including a dependent or unmarried victim within a household, is enrolled in minimum essential coverage and seeks to enroll in coverage separate from the perpetrator of the abuse or abandonment; or
  - (ii) Is a dependent of a victim of domestic abuse or spousal abandonment, on the same application as the victim, may enroll in coverage at the same time as the victim;
- (11) A qualified individual or dependent—
  - (i) Applies for coverage through NYSOH during the annual open enrollment period or due to a qualifying event, is assessed as potentially eligible for Medicaid or Child Health Plus and is determined ineligible for Medicaid or Child Health Plus either after

open enrollment has ended or more than 60 days after the qualifying event; or

- (ii) Applies for coverage at their Local Department of Social Services or Human Resources Administration during the annual open enrollment period, and is determined ineligible for Medicaid or Child Health Plus after open enrollment has ended;
- (12) The qualified individual or enrollee, or his or her dependent, adequately demonstrates to NYSOH that a material error related to plan benefits, service area, or premium influenced the qualified individual's or enrollee's decision to purchase a qualified health plan; or
- (13) At the option of NYSOH, the qualified individual provides satisfactory documentary evidence to verify his or her eligibility for an insurance affordability program or enrollment following termination of enrollment due to a failure to verify such status within 90 days.

(45 CFR § 155.420(d)).

Generally, if a triggering life event occurs, the qualified individual or enrollee has 60 days from the date of a triggering event to select a qualified health plan (45 CFR § 155.420(c)(1)).

However, a loss of health insurance coverage such as that referenced above does not include,

"voluntary termination of coverage or other loss due to—

- (1) Failure to pay premiums on a timely basis, including COBRA premiums prior to expiration of COBRA coverage, or
- (2) Situations allowing for a rescission as specified in 45 CFR [§] 147.128" such as failure to comply with other requirements (45 CFR § 147.128(b))

(45 CFR § 155.420(e)).

## **Legal Analysis**

The first issue under review is whether your QHP was properly cancelled for non-payment of premiums.

The record reflects that you initially enrolled in a QHP on January 4, 2017. On January 5, 2017, NYSOH issued you an enrollment notice confirming that your QHP enrollment start date was February 1, 2017 (Document).

Based on that notice, you contacted NYSOH and requested that your QHP have an enrollment start date of January 1, 2017.

On January 24, 2017, your request for a January 1, 2017 enrollment start date was granted. You testified that you were notified by NYSOH at the end of January 2017, that your request to change your enrollment start date was granted. Further, you testified that you did not pay the January 2017 health insurance premium because the month was almost over.

According to your NYSOH account, on February 2, 2017, the health plan initiated termination of your coverage. NYSOH issued a disenrollment notice on February 3, 2017, stating that your coverage would end January 1, 2017, because you did not pay your insurance bill by the payment deadline.

NYSOH Appeals Unit only has the authority to review issues related to the following: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (3) an eligibility determination for an exemption, (4) a failure to provide timely notice of an eligibility determination and (5) a denial of a special enrollment period.

Since the Appeals Unit is not given the authority to review termination of enrollment due to non-payment of premiums, we cannot reach the merits as to whether or not you were properly terminated from your health plan for non-payment of premiums. Therefore, your appeal regarding whether your QHP was properly cancelled for non-payment of premiums is DISMISSED.

The second issue under review is whether NYSOH properly determined that you did not qualify to enroll in a QHP outside of the open enrollment period.

You testified that you are seeking reinstatement of your health plan through NYSOH, prospectively.

NYSOH provided an open enrollment period from November 1, 2016 until January 31, 2017. Once the annual open enrollment period ends, a health plan

enrollee must qualify for a special enrollment period in order to enroll in, or change to another health plan offered in NYSOH. In order to qualify for a special enrollment period, a person must experience a triggering event.

The loss of health insurance coverage in this case cannot be considered a triggering event for a special enrollment period, because it was a result of non-payment of your premiums, which NYSOH considers a voluntary action causing the termination of your coverage.

You testified that since filing your application on December 15, 2016, there have been no other major changes to your household.

The credible evidence of record indicates that, since the open enrollment period closed on January 31, 2017, you have not experienced a triggering event that would qualify you for a special enrollment period.

Therefore, the denial of a special enrollment period is AFFIRMED.

#### Decision

Your appeal regarding whether your QHP was properly cancelled for non-payment of premiums is DISMISSED as a non-appealable issue.

The March 31, 2017 plan enrollment notice is AFFIRMED insofar as it confirms that you did not qualify to select a health plan outside of the open enrollment period for 2017.

## **How this Decision Affects Your Eligibility**

You did not qualify for a special enrollment period, as of the March 31, 2017 plan enrollment notice.

## If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This

must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).

## **Summary**

Your appeal regarding whether your QHP was properly cancelled for non-payment of premiums is DISMISSED as a non-appealable issue.

The March 31, 2017 plan enrollment notice is AFFIRMED insofar as it confirms that you did not qualify to select a health plan outside of the open enrollment period for 2017.

You did not qualify for a special enrollment period, as of the March 31, 2017 plan enrollment notice.
