## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your son's eligibility for, and enrollment in, an Essential Plan was effective August 1, 2017?

## Procedural History

On March 24, 2017, you completed an application for financial assistance with health insurance on behalf of yourself and your family.

On March 25, 2017, NYSOH issued a notice of eligibility determination, stating that your son was eligible to enroll in the Essential Plan, effective May 1, 2017.

On June 24, 2017, you updated your NYSOH account.

On June 25, 2017, NYSOH issued a notice of eligibility determination, based on your June 24, 2017 application, stating that your son was eligible to enroll in the Essential Plan with a \$20.00 monthly premium, effective August 1, 2017.

On June 26, 2017, you selected an Essential Plan for enrollment for your son. That same day, you spoke to NYSOH's Account Review Unit and appealed the start date of your son's eligibility for, and enrollment in, his Essential Plan coverage, insofar as it did not begin July 1, 2017.

On June 27, 2017, NYSOH issued a notice of enrollment confirmation, based on your plan selection on June 26, 2017, stating that your son was enrolled in an Essential Plan, and that his enrollment would begin on August 1, 2017.

On September 18, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record support the following findings of fact:

- 1) You first submitted an application to NYSOH for financial assistance on March 24, 2017.
- 2) You testified that you did not enroll your family in coverage at that time because you found out that you were going to have coverage through COBRA.
- 3) You testified that you received a notice in June 2017 that your family's COBRA coverage had been terminated as of April 30, 2017 for nonpayment of the premium. You testified that you had mistakenly believed that you had sixty days to make your COBRA premium payment.
- 4) You testified that you contacted NYSOH to update your application, and that you were told that your son would have coverage beginning on August 1, 2017.
- 5) Your NYSOH account reflects that you updated your account on June 24, 2017, and you selected an Essential Plan on behalf of your son on June 26, 2017.
- 6) You testified that you spoke to a NYSOH agent because you did not understand why your son's coverage did not begin on July 1, 2017, and you were informed that his coverage could not start until August 1, 2017 because you enrolled him in coverage after the fifteenth of the month.
- 7) You testified that your son does not have any medical bills for the month of July 2017, but you are concerned that he will incur a tax penalty if he does not have coverage beginning July 1, 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

## **Legal Analysis**

The issue under review is whether NYSOH properly determined that your son's eligibility for, and enrollment in, his Essential Plan coverage was effective August 1, 2017.

You testified that you updated your NYSOH application in June 2017, after your family lost COBRA coverage, and the record indicates that your NYSOH application was updated on June 24, 2017. As a result, your son was found eligible for the Essential Plan as of August 1, 2017, and you enrolled him into a plan on June 26, 2017.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On June 26, 2017, you selected an Essential Plan on behalf of your son, so his enrollment properly took effect on the first day of the second month following June: that is, on August 1, 2017.

Therefore, the June 25, 2017 eligibility determination and June 27, 2017 enrollment confirmation notices, stating that your son's eligibility for, and enrollment in, the Essential Plan was effective August 1, 2017, are correct and must be AFFIRMED.

## **Decision**

The June 25, 2017 eligibility determination is AFFIRMED.

The June 27, 2017 enrollment confirmation notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your son's eligibility.

The effective date of your son's Essential Health Plan coverage is August 1, 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
