Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your youngest eight children's enrollment in their Child Health Plus plan ended effective April 30, 2017?

Procedural History

On November 30, 2016, NY State of Health (NYSOH) issued a notice of eligibility determination, based on your November 29, 2016 application, stating that your youngest eight children were eligible to enroll in Child Health Plus with a \$9.00 monthly premium, effective January 1, 2017

Also on November 30, 2016, NYSOH issued a notice of enrollment, based on your plan selection on November 29, 2016, stating that your youngest eight children were enrolled in a Child Health Plus plan, and that this enrollment in the plan would start January 1, 2017.

On February 15, 2017, NYSOH issued a 1095A form.

On March 6, 2017, the February 15, 2017 1095A form was returned to NYSOH as undeliverable. This returned notice was uploaded to your NYSOH account on April 18, 2017.

On April 18, 2017, NYSOH issued a notice of discontinuance stating that your youngest eight children were no longer eligible to receive health insurance

through NYSOH, effective May 1, 2017, because notices regarding your household's eligibility and coverage sent to you by NYSOH were returned to the Marketplace as undeliverable. This notice also stated that you needed to update your mailing address so that your children could remain eligible for health coverage through NYSOH.

Also on April 18, 2017, NYSOH issued a disenrollment notice, stating that your youngest eight children's Child Health Plus coverage would end April 30, 2017.

On April 24, 2017, NYSOH received your updated application for financial assistance.

On April 25, 2017, NYSOH issued an eligibility determination notice stating that your youngest eight children were eligible for Child Health Plus, effective June 1, 2017.

Also on April 25, 2017, NYSOH issued a notice confirming your mailing address.

On April 26, 2017, NYSOH issued an enrollment confirmation notice stating that your youngest eight children were enrolled in a Child Health Plus plan, effective June 1, 2017.

On May 16, 2017, NYSOH received your letter dated May 10, 2017, in which you request an appeal of your youngest eight children's disenrollment from their Child Health Plus plan as of May 1, 2017. This letter was uploaded to your account on May 20, 2017.

On June 28, 2017, NYSOH issued a notice confirming that you filed an appeal regarding the eligibility determination for your youngest eight children.

On September 20, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing your youngest eight children's disenrollment from their Child Health Plus plan, effective April 30, 2017.
- 2) You testified, and the record reflects, that your youngest eight children were enrolled in a Child Health Plus plan with a \$9.00 monthly premium, effective January 1, 2017.

- 3) The record indicates that your youngest eight children were disenrolled from their Child Health Plus plan, effective April 30, 2017.
- 4) According to your NYSOH account, the February 15, 2017 1095A form was returned as undeliverable to NYSOH on March 6, 2017.
- 5) The record reflects that no other NYSOH notices were returned as undeliverable.
- 6) The record reflects that all notices sent to you have been addressed to [REDACTED].
- 7) You testified that this address was correct, and that you have lived at that address for ten years.
- 8) You testified that you need to have your youngest eight children's Child Health Plus plan reinstated for May 2017 because you have outstanding medical bills for services rendered.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

"A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage" (42 CFR § 457.340(f)).

The State of New York has provided that a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is

received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue under review is whether NYSOH properly determined that your youngest eight children's enrollment in a Child Health Plus plan ended effective April 30, 2017.

For an applicant to remain eligible for enrollment in a Child Health Plus plan through NYSOH, they must meet both the financial and non-financial requirements. One of the non-financial requirements is that the applicant must be a New York State Resident.

According to your NYSOH account, on February 15, 2017, NYSOH issued a 1095A form that was returned to NYSOH as undeliverable on March 6, 2017.

As a result, your youngest eight children were subsequently disenrolled from their Child Health Plus plan because NYSOH received mail addressed to you that was undeliverable; therefore, the system assumed that your youngest eight children no longer met the state residency requirement for enrollment in a Child Health Plus plan. As such, on April 18, 2017, NYSOH issued a discontinuance notice and a plan disenrollment notice, stating that your youngest eight children were no longer eligible to enroll in a Child Health Plus plan and their coverage in a Child Health Plus plan would end effective April 30, 2017.

However, a review of the record reflects that the February 15, 2017 1095A form was the only notice returned as undeliverable, despite several other notices being successfully sent to the exact same address. You testified, and the record reflects, that your address is: [REDACTED] and that you have lived there for ten years.

Based on the credible evidence of the record, since the February 15, 2017 notice was the only notice returned as undeliverable to NYSOH despite other notices being sent to the same mailing address, it is reasonable to conclude that this notice was returned as undeliverable through no fault of your own, and was the result of an error of the United State Postal Service. As a result, it is reasonable to conclude that your youngest eight children's disenrollment from their Child Health Plus plan was in error because they continued to meet the state residency requirement.

Therefore, the April 18, 2017 discontinuance notice and April 18, 2017 plan disenrollment notice must be **RESCINDED**.

Your case is RETURNED to NYSOH to reinstate your youngest eight children in their Child Health Plus plan, effective May 1, 2017, and to notify you accordingly.

Decision

The April 18, 2017 discontinuance notice is RESCINDED.

The April 18, 2017 plan disenrollment notice is RESCINDED.

Your case is RETURNED to NYSOH to effectuate the changes to your account as noted above, and to notify you accordingly.

How this Decision Affects Your Eligibility

Your case is sent back to NYSOH to reinstate your youngest eight children in their Child Health Plus plan effective May 1, 2017.

NYSOH will notify you once this change has been completed.

It is your responsibility to pay any outstanding monthly premiums directly to your children's Child Health Plus plan.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
