Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that you were eligible to receive up to \$217.00 per month in advance payments of the premium tax credit, effective August 1, 2017?

Did NY State of Health properly determine that you were ineligible for cost-sharing reductions?

Did NY State of Health properly determine that you were ineligible for the Essential Plan?

Did NY State of Health properly determine that you were ineligible for Medicaid?

Procedural History

On June 30, 2017, you submitted an application for financial assistance.

On July 1, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to receive up to \$217.00 per month in advance payments of the premium tax credit (APTC) for a limited time, effective August 1, 2017. That notice also stated that you were not eligible for the Essential Plan and Medicaid because your income was over the allowable income limits for those programs. This notice also directed you to submit income documentation by September 28,

2017 in order to confirm your eligibility for financial assistance with health insurance.

On July 6, 2017, you spoke to NYSOH's Account Review Unit and appealed insofar as you were not found eligible for additional financial assistance.

On September 28, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and left open for fourteen days to allow you the opportunity to submit income documentation.

On October 6, 2017, the Appeals Unit received via fax copies of your final paystub and your unemployment benefit payment history. These documents were collectively marked as Appellant's Exhibit #1 and incorporated into the record. The record is now closed.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of single and you will claim no dependents on that tax return.
- 2) You are seeking insurance for yourself.
- 3) The application that was submitted on June 30, 2017 listed annual household income of \$32,180.00, consisting of \$21,000.00 in wages and \$11,180.00 in unemployment benefits.
- 4) You testified that you last worked on May 3, 2017. You testified that you received no severance pay and that you earned a gross year to date amount of \$28,000.00 from your employer.
- 5) You testified that you filed for unemployment benefits in the last week of May 2017 and receive a gross amount of \$430.00 per week in unemployment benefits from which child support is deducted for a net payment of \$219.00 per week.
- 6) You testified that you received no paychecks in June 2017 and your only source of income that month were your unemployment benefits.
- 7) Your application states, and you confirmed, that you will not be taking any deductions on your 2017 tax return.
- 8) Your application states, and you confirmed that you live in [REDACTED].

- 9) Following the hearing you submitted a paystub for the period May 13, 2017 to May 26, 2017 showing that you had no earnings for that period and were being paid the value of your vacation time. This paystub shows a year to date gross amount of \$21,893.14 for your employer.
- 10) You submitted a record of unemployment benefit payment history which shows that your claim was effective May 8, 2017. The payment history shows that on June 7, 2017 you received a gross amount of \$860.00 in unemployment benefits and on June 8, 2017, June 15, 2017, June 22, 2017, June 30, 2017, July 6, 2017, July 13, 2017, July 20, 2017, July 27, 2017, August 3, 2017, August 10, 2017, August 17, 2017, August 24, 2017, August 31, 2017, September 8, 2017, September 14, 2017, September 28, 2017, and October 5, 2017 you received a gross amount of \$430.00 in unemployment benefits. This document also notes that you have twenty-eight effective days remaining.
- 11) You testified that you have bills including \$70.00 per month for internet and cable, \$75.00 every two months for propane, \$1,000.00 per year for oil, \$40.00 to \$50.00 per month for electric, \$138.00 per month for car insurance, and \$135.00 per week for child support, that you would like considered when determining your eligibility for financial assistance.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Advance Payments of Premium Tax Credit

Advance payments of the premium tax credit (APTC) are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

- 1) the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2017 is set by federal law at 2.04% to 9.69% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3T(g)(1), IRS Rev. Proc.2016-24).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Federal Register 4036).

For annual household income in the range of at least 250% but less than 300% of the 2016 FPL, the expected contribution is between 8.21% and 9.69% of the household income (26 CFR § 1.36B-3T(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2016-24).

People who use the APTC to help pay health insurance premiums must file a federal tax return and reconcile their expected income (stated on NYSOH application) with their actual income (stated on their federal income tax return). Those who take less tax credit in advance than they claim on the tax return may get the rest of it as an income tax refund or have their tax bill reduced. Those who take more tax credit in advance than they can claim on their tax return will owe the difference as additional income taxes (26 CFR § 1.36B-4).

Cost-Sharing Reductions

Cost-sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their

immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Fed. Reg. 4036).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Modified Adjusted Gross Income

NYSOH bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code (45 CFR § 155.300(a)). The term “modified adjusted gross income” means adjusted gross income increased by (1) any income that was excluded under 26 USC § 911 for United States citizens or residents living abroad, (2) tax-exempt interest received or accrued, and (3) Social Security benefits that were excluded from gross income under 26 USC § 86 (see 26 USC § 36B(d)(2)(B), 26 CFR § 1.36B-1(e)(2)).

“Adjusted gross income” means, in the case of an individual taxpayer, gross federal taxable income minus certain specific deductions, such as expenses reimbursed by an employer, losses from sale or exchange of property, losses from premature withdrawal of funds from tax savings accounts, deductions attributable to royalties, and certain retirement savings (26 USC § 62(a)). Living expenses, such as rent and utilities are not an allowable deduction in computing adjusted gross income.

Generally, payments made for the support of children cannot be deducted by the parent who is making the payments (26 USC § 71(c)(1)).

Legal Analysis

The first issue is whether NYSOH properly determined that you were eligible for an APTC of up to \$217.00 per month.

The application that was submitted on June 30, 2017 listed an annual household income of \$32,180.00 and the eligibility determination relied upon that information.

During the hearing, you asked that your current expenses, which include \$70.00 per month for internet and cable, \$75.00 every two months for propane, \$1,000.00 per year for oil, \$40.00 to \$50.00 per month for electric, \$138.00 per month for car insurance, and \$135.00 per week for child support, be considered when calculating your eligibility for financial assistance.

Since the Internal Revenue Service rules do not allow living expenses such as rent, utilities, cable and phone to be deducted from the calculation of your adjusted gross income, they cannot be deducted when NYSOH computes your modified adjusted gross income for financial assistance purposes.

Additionally, the Internal Revenue Service rules do not allow child support to be deducted by the parent making such payments, therefore, these payments cannot be deducted when NYSOH computes your modified adjusted gross

income for financial assistance purposes. Therefore, NYSOH correctly determined your household income to be \$32,180.00.

You expect to file your 2017 income taxes as single and will claim no dependents on that tax return. Therefore, you are in a one-person household.

You reside in Suffolk County, where the second lowest cost silver plan available for an individual through NYSOH costs \$453.37 per month.

An annual income of \$32,180.00 is 270.88% of the 2016 FPL for a one-person household. At 270.88% of the FPL, the expected contribution to the cost of the health insurance premium is 8.83% of income, or \$236.74 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual in your county (\$453.37 per month) minus your expected contribution (\$236.74 per month), which equals \$216.63 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you to be eligible for up to \$217.00 per month in APTC.

The second issue is whether you were properly found ineligible for cost-sharing reductions. Cost-sharing reductions are available to a person who has a household income no greater than 250% of the FPL. Since a household income of \$32,180.00 is 270.88% of the applicable FPL, NYSOH correctly found you to be ineligible for cost sharing reductions.

The third issue under review is whether NYSOH properly determined that you were ineligible for the Essential Plan.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,880.00 for a one-person household. Since an annual household income of \$32,180.00 is 270.88% of the 2016 FPL, NYSOH properly found you to be ineligible for the Essential Plan.

The fourth issue is whether NYSOH properly determined that you were ineligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$12,060.00 for a one-person household. Since \$32,180.00 is 266.83% of the 2017 FPL, NYSOH properly found you to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

You submitted your record of unemployment benefit payment history that shows in June 2017 you received \$2,580.00.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,387.00 per month. Since the documentation you provided shows that you received \$2,580.00 in June 2017 you do not qualify for Medicaid on the basis of monthly income as of the date of your application.

Since the July 1, 2017 eligibility determination notice properly stated that, based on the information you provided, you were eligible for up to \$217.00 per month in APTC, ineligible for cost-sharing reductions, ineligible for the Essential Plan and ineligible for Medicaid, it is correct and is AFFIRMED.

Following the hearing, you submitted documentation that shows that you received \$21,893.14 from your employment and will receive \$11,180.00 in unemployment benefits in 2017. Therefore, your annual expected income for 2017 is \$33,073.14.

Your case is RETURNED to NYSOH to recalculate your eligibility for financial assistance based on a household of one, residing in [REDACTED], with an annual expected income of \$33,073.14.

Decision

The July 1, 2017 eligibility determination notice is AFFIRMED.

Your case is RETURNED to NYSOH to recalculate your eligibility for financial assistance based on a household of one, residing in [REDACTED], with an annual expected income of \$33,073.14.

This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
