## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Was your appeal of NY State of Health's (NYSOH) December 7, 2016 eligibility determination notice timely?

## Procedural History

On December 7, 2016, NYSOH issued a notice stating that you were eligible to enroll in a qualified health plan (QHP) and to receive up to \$301.00 per month in advance payments of the premium tax credit (APTC) effective January 1, 2017. This determination was based on annual household earnings of \$35,488.00. You were also eligible to receive cost-sharing reductions (CSR) if you enrolled in a silver-level plan.

You were subsequently enrolled in a gold-level QHP, effective January 1, 2017.

On July 5, 2017, you updated your application, changing the annual household earnings on your application to \$30,722.46. At that time, you were found conditionally eligible to enroll in the Essential Plan, effective August 1, 2017.

Also on July 5, 2017, you spoke to NYSOH's Account Review Unit and filed an appeal, requesting that your eligibility beginning January 1, 2017 be redetermined, and that your enrollment in the Essential Plan be backdated to January 1, 2017.

On September 28, 2017, you appeared at a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing, and closed at the end of the hearing.

## **Findings of Fact**

A review of the record support the following findings of fact:

- 1) On December 6, 2016, you applied for health insurance and financial assistance through NYSOH, and were found eligible to enroll in a QHP and to receive up to \$301.00 per month in APTC effective January 1, 2017. You were then enrolled in a plan.
- 2) You testified that you met with a counselor in July 2017, who thought you were paying too much for your coverage. It was then you discovered that you could deduct pre-tax deductions from your annual household earnings when applying for financial assistance through NYSOH. When you reapplied using what you deemed to be your correct annual household earnings, you were found conditionally eligible for the Essential Plan.
- 3) Your NYSOH account reflects that you filed your appeal on July 5, 2017.
- 4) You testified that you want your coverage in the Essential Plan to be backdated to January 1, 2017 from August 1, 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Valid Appeal Requests

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR § 155.505; and (4) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

Individual applicants and enrollees must request a hearing within sixty (60) days of the date of their notice of eligibility determination by NYSOH (45 CFR § 155.520(b)(2); 18 NYCRR 358-3.5(b)(1)).

## **Legal Analysis**

The only issue under review is whether your appeal of NYSOH's December 7, 2016 eligibility determination notice was timely.

On December 7, 2016, NYSOH issued an eligibility determination notice stating that you were eligible to enroll in a QHP and to receive up to \$301.00 per month in APTC effective January 1, 2017. You were then enrolled in a plan.

Individual applicants and enrollees must request a hearing within 60 days of the date of their notice of eligibility determination by NYSOH.

For an appeal to have been valid on the issue of eligibility as of January 1, 2017, an appeal should have been filed by February 5, 2017. The record reflects that the first time you called NYSOH to file a complaint about your eligibility and enrollment as of January 1, 2017 was July 5, 2017, which is well beyond the sixty day timeframe.

As such there has been no timely appeal of the December 7, 2016 eligibility determination notice, and your appeal must be DISMISSED.

## **Decision**

Your appeal of the December 7, 2016 eligibility determination notice is untimely and is DISMISSED.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.
