Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible to receive up to \$332.00 per month in advance payments of the premium tax credit, effective July 1, 2017 and August 1, 2017?

Did NYSOH properly determine that you were eligible for cost-sharing reductions?

Did NYSOH properly determine that you were not eligible for the Essential Plan?

Did NYSOH properly determine that you were not eligible for Medicaid?

Procedural History

On June 12, 2017, you submitted an application for financial assistance.

On June 13, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to receive an advance premium tax credit (APTC) of up to \$332.00 per month and, if you selected a silver-level plan for your enrollment, eligible for cost-sharing reductions (CSR), effective July 1, 2017. That notice also stated that you were not eligible for either the Essential Plan or Medicaid because your income was over the allowable income limits for those programs.

On July 3, 2017, you submitted a revised application for financial assistance.

On July 4, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to receive an APTC of up to \$332.00 per month and, if you selected a silver-level plan for your enrollment, eligible for CSR, effective August 1, 2017. That notice also stated that you were not eligible for either the Essential Plan or Medicaid because your income was over the allowable income limits for those programs.

On July 6, 2017, you spoke to NYSOH's Account Review Unit and appealed that you had not been found eligible for either the Essential Plan or Medicaid.

On September 26, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and remained open as the Hearing Officer directed you to provide as additional evidence to corroborate your testimony: all earnings statements you received from your employer. The record was to be closed at 5:00 p.m. ET on September 29, 2017, or upon the receipt of the above referenced documents, whichever occurred earlier.

On September 29, 2017, prior to 5:00 p.m. ET, you provided to NYSOH Appeals Unit through facsimile: (1) a [REDACTED], issued by [REDACTED] on September 25, 2017, reflecting payments by you for prescription medication between June 25, 2017 and September 25, 2017, (2) four earnings statements issued to you by your employer, [REDACTED], reflecting payment made to you between June 16, 2017 and July 28, 2017, and (3) a letter from you supporting your request for your eligibility for either the Essential Plan or Medicaid.

Accordingly, the record was closed on September 29, 2017

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of single. You will claim no dependents on that tax return.
- 2) You are seeking insurance for yourself only.
- 3) The application that were submitted on June 12, 2017 and July 3, 2017 each listed annual household income of \$28,106.00, consisting of \$1,081.00 you earn from [REDACTED] once every two weeks. You testified that this amount was correct.

- 4) Your application states that you will not be taking any deductions on your 2017 tax return. You testified that while you do pay some student loans, the amount of deductible interest is negligible.
- 5) You live in [REDACTED], New York.
- 6) You testified that the cost of the insurance plans through NYSOH, combined with the co-pays for prescriptions and doctors' visits, make any plans other than the Essential Plan and Medicaid unaffordable. You further testified that this is especially true since you have several medical conditions that require frequent physician visits and prescription medication.
- 7) On September 29, 2017, you provided to NYSOH four earnings statements reflecting that you received (1) \$1,171.46 on June 16, 2017, (2) \$1,182.33 on June 30, 2017, (3) \$1,140.39 on July 14, 2017, and (4) \$1,140.33 on July 28, 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Advance Payments of Premium Tax Credit

Advance payments of the premium tax credit (APTC) are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

- 1) the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

- 2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2017 is set by federal law at 2.04% to 9.69% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3T(g)(1), IRS Rev. Proc.2016-24).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Federal Register 4036).

For annual household income in the range of at least 200% but less than 250% of the 2016 FPL, the expected contribution is between 6.43% and 8.21% of the household income (26 CFR § 1.36B-3T(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2016-24).

Cost-Sharing Reductions

Cost-sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Fed. Reg. 4036).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Legal Analysis

The first issue is whether NYSOH properly determined that you were eligible for an APTC of up to \$332.00 per month.

The applications that were submitted on June 12, 2017 and July 3, 2017 each listed an annual household income of \$28,106.00 and the eligibility determinations relied upon that information.

You are in a one-person household. You expect to file your 2017 income taxes as single and will claim no dependents on that tax return.

You reside in Onondaga County, where the second lowest cost silver plan available for an individual through NYSOH costs \$513.31 per month.

An annual income of \$28,106.00 is 236.58% of the 2016 FPL for a one-person household. At 236.58% of the FPL, the expected contribution to the cost of the health insurance premium 7.73% of income, or \$181.10 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual in your county (\$513.31 per month) minus your expected contribution (\$181.10 per month), which equals \$332.21 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you to be eligible for up to \$332.00 per month in APTC.

The second issue is whether you were properly found eligible for CSR.

CSR is available to a person who has a household income no greater than 250% of the FPL. Since a household income of \$28,106.00 is 236.58% of the applicable FPL, NYSOH correctly found you to be eligible for CSR.

The third issue under review is whether NYSOH properly determined that you were not eligible for the Essential Plan.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,880.00 for a one-person household. Since an annual household income of \$28,106.00 is 236.58% of the 2016 FPL, NYSOH properly found you to be eligible for the Essential Plan.

The fourth issue is whether NYSOH properly determined that you were not eligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$12,060.00 for a one-person household. Since \$28,106.00 is 233.05% of the 2017 FPL, NYSOH properly found you to be not eligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

On September 29, 2017, you submitted to NYSOH Appeals Unit, at the direction of the Hearing Officer, four earnings statements covering all income you received from your employer during the months of June and July 2017.

The credible evidence of record reflects that you received \$2,353.79 and \$2,280.72 in gross income during the months of June and July 2017, respectively.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,387.00 per month. Since the documentation you provided shows that you earned \$2,353.79 and \$2,280.72 during June and July 2017, respectively, you do not qualify for Medicaid based on monthly income as of the date of your June and July 2017 applications.

Since the June 13, 2017 and July 4, 2017 eligibility determination notices each properly stated that, based on the information you provided, you were eligible for up to \$332.00 per month in APTC, eligible for CSR, not eligible for the Essential Plan and not eligible for Medicaid, they are correct and AFFIRMED.

Decision

The June 13, 2017 eligibility determination notice is AFFIRMED.

The July 4, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You remain eligible for an APTC of up to \$332.00 per month and, if you selected a silver-level plan for enrollment, eligible for CSR.

You are not eligible for the Essential Plan.

You are not eligible for Medicaid.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This
