NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On June 29, 2017, NY State of Health (NYSOH) issued an eligibility determination and disenrollment notices stating in respective part that you were no longer eligible for health insurance through NYSOH because a formal notice mailed to your mailing address had been returned as undeliverable and, therefore, your enrollment in your Medicaid Managed Care plan would end July 1, 2017. On July 6, 2017, NYSOH issued eligibility determination and plan enrollment notices stating in respective part that you were eligible for Medicaid, effective July 1, 2017, and your coverage in your Medicaid Managed Care plan would resume August 1, 2017. You appealed the enrollment date that your Medicaid Managed Care plan was to resume and requested that the hearing on your appeal be expedited, which was granted.

On July 10, 2017, NYS Department of Health conducted an override and your coverage in your Medicaid Managed Care plan was backdated to July 1, 2017. On July 11, 2017, NYSOH issued a plan enrollment notice to this effect.

On July 11, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because the issue on appeal had been resolved in your favor.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
