## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in an Essential Plan was effective August 1, 2017?

## Procedural History

On July 10, 2017, you submitted an updated application for financial assistance with health insurance. That day, a preliminary determination was prepared, stating that you were eligible for the Essential Plan, effective August 1, 2017.

Also on July 10, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in the Essential Plan insofar as it did not begin July 1, 2017.

On July 11, 2017, NYSOH issued a notice of eligibility determination, based on your July 10, 2017 application, stating that you were eligible to enroll in the Essential Plan, effective August 1, 2017.

Also on July 11, 2017, NYSOH issued a notice of enrollment, based on your plan selection on July 10, 2017, stating that you were enrolled in an Essential Plan, and that your plan would start August 1, 2017.

On November 22, 2017, you had a scheduled telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. You requested an opportunity to have an

authorized representative present, and the Hearing Officer agreed to adjourn your hearing to a later date.

On November 30, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. You authorized [REDACTED] to assist you during the hearing. The record was developed during the hearing and held open up to December 15, 2017, to allow you time to submit documentation.

On December 6, 2017, NYSOH received the documentation and it was entered into the record as Appellant's Exhibit #1. The record was closed that day.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on July 10, 2017.
- 2) You testified, and the record reflects, that you enrolled in an Essential Plan on July 10, 2017.
- 3) You testified that you wanted your coverage to begin on July 1, 2017 because you have outstanding bills for medical services rendered that month.
- 4) On December 6, 2017, you sent to NYSOH's Appeals Unit a copy of your 2016 income tax return and a benefit award letter from the Social Security Administration.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

## **Legal Analysis**

The issue is whether NYSOH properly determined that your enrollment in the Essential Plan was effective August 1, 2017.

You testified, and the record indicates, that you updated your NYSOH application on July 10, 2017. As a result, you were found eligible for the Essential Plan as of August 1, 2017 and enrolled into a plan that day.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On July 10, 2017, you selected an Essential Plan, so your enrollment properly took effect on the first day of the first month following July 2017; that is, on August 1, 2017.

Therefore, the July 11, 2017 enrollment confirmation notice stating that your enrollment in the Essential Plan was effective August 1, 2017, is correct and must be AFFIRMED.

## **Decision**

The July 11, 2017 enrollment confirmation notice is AFFIRMED.

### **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
