## **NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL**

On July 11, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible for up to \$218.00 per month in advanced premium tax credits, and cost-sharing reductions if you enrolled into a silver-level qualify health plan, effective August 1, 2017. You appealed that determination.

On September 26, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because your income has recently changed. You have already updated your NYSOH account, and are in the process of having your eligibility redetermined.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

### **How does this Dismissal Affect Your Eligibility?**

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
