Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your Medicaid Managed Care plan was effective April 1, 2017?

Procedural History

On November 16, 2016, NYSOH issued a notice stating that your Medicaid coverage through [REDACTED] Department of Social Services (LDSS) would end on January 31, 2017. The notice advised you to log into your NYSOH account between December 16, 2016 and January 15, 2017 to complete the renewal process. This letter was mailed to the following address:

On March 6, 2017, NYSOH received an update to your application for health insurance. This application stated that you now resided at your current address:

On March 7, 2017, NYSOH issued a notice of eligibility determination, based on your March 6, 2017 application, stating that you were eligible for Medicaid, effective March 1, 2017.

Also on March 7, 2017, NYSOH issued an enrollment notice confirming your selection of a Medicaid Managed Care (MMC) plan for your enrollment as of March 6, 2017. The notice state that your MMC plan coverage would start on April 1, 2017.

On July 10, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in your MMC plan, insofar as it did not begin on March 1, 2017.

On October 4, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record support the following findings of fact:

- 1) Your NYSOH account reflects that you receive all your notices from NYSOH by regular mail.
- 2) You testified that you did not receive any notices from NYSOH telling you that you needed to update your application to renew your Medicaid coverage through NYSOH.
- 3) You testified that you did not know that you needed to update your account until you had incurred a pharmaceutical bill of approximately \$892.00 during March 2017 relating to a [REDACTED] condition.
- 4) You testified that the pharmacy company you received the mediation from will no longer provide you with the necessary medical accessories until the prior bill is paid in full.
- 5) No notices sent to you at the address listed on your NYSOH account have been returned as undeliverable.
- 6) You testified that you resided at [REDACTED] during the time that you were enrolled in Medicaid through LDSS, but did not likely receive any NYSOH mailings since you were in the process of being evicted from that location.

- 7) Your NYSOH account reflects that you updated your application on March 6, 2017 to show that you are now living at [REDACTED] - [REDACTED]
- 8) You testified that you want your MMC plan coverage through NYSOH to begin on March 1, 2017 because you need pharmacy coverage during March 2017, with the expectation that that company will coverage your pharmaceuticals and accessories going forward during 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Legal Analysis

The issue is whether NYSOH properly determined that your enrollment in the MMC plan was effective April 1, 2017.

You testified, and your NYSOH account reflects, that you contacted NYSOH on March 6, 2017 and enrolled into an MMC plan.

You testified that you did not receive any notice from NYSOH telling you that you needed to update the information in your NYSOH account. You testified, and your NYSOH account confirms, that you elected to receive notifications by regular mail. However, there is no evidence in the record that any of the notices that were sent to your mailing address were returned as undeliverable.

While you testified that you were in the process of eviction from your prior address when the November 16, 2016 renewal notice was issued. There is no evidence that you made any attempt to update your address through NYSOH prior to March 6, 2017.

Therefore, the record reflects that NYSOH properly notified you of your renewal through NYSOH and that information in your NYSOH account needed to be updated between December 16, 2016 and January 15, 2017 in order to ensure your enrollment in your health plan and eligibility for financial assistance would continue uninterrupted.

The record shows that on March 6, 2017 you updated the information in your NYSOH account and submitted a request to enroll in an MMC plan.

The date on which a MMC plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On March 6, 2017, you selected an MMC plan, so it properly took effect on the first day of the first month following March 2017; that is, on April 1, 2017.

Therefore, the March 7, 2017 enrollment notice stating that your enrollment in your MMC plan coverage would be effective April 1, 2017, was correct and must be AFFIRMED.

Decision

The March 7, 2017 enrollment notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

The effective date of your MMC plan is April 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
