Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible to enroll in the Essential Plan, effective August 1, 2017?

Did NYSOH properly determine that you were not eligible for Medicaid?

Procedural History

On March 2, 2017, NYSOH issued an eligibility determination stating that you were no longer eligible for Medicaid; however, your Medicaid eligibility would continue until July 31, 2017, because certain individuals who qualified for Medicaid get coverage for 12 continuous months from the date they were last determined eligible. This eligibility determination was effective March 1, 2017.

Also on March 2, 2017, NYSOH issued an enrollment notice confirming your enrollment in a Medicaid Managed Care (MMC) plan as of March 1, 2017. Your coverage began effective August 1, 2016.

On June 3, 2017, NYSOH issued a renewal and eligibility determination notice based on information in the application you submitted on March 1, 2017, stating that you were eligible for the Essential Plan with a \$20.00 monthly premium, effective August 1, 2017. You were advised to select a health plan between June 16, 2017 and July 15, 2017 for the next coverage year.

On June 18, 2017, NYSOH issued an enrollment notice confirming your selection of an Essential Plan as of June 16, 2017, with such coverage to begin effective August 1, 2017.

On July 10, 2017, you contacted NYSOH's Account Review Unit and requested an appeal of that eligibility determination insofar as you were not eligible for Medicaid.

On October 13, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of single. You will claim no dependents on that tax return.
- 2) You are seeking insurance for yourself only.
- 3) Your eligibility was redetermined based on information contained in the March 1, 2017 application, which listed an annual household income of \$21,528.00, consisting of \$414.00 you receive from your employment with [REDACTED]. You testified that this amount was correct as of March 1, 2017, and remains correct.
- 4) You testified that your gross income during the month of the redetermination of your eligibility, June 2017, was \$1,656.00, consisting of four separate payments of \$414.00.
- 5) Your application states that you will not be taking any deductions on your 2017 tax return.
- 6) You live in [REDACTED], New York.
- 7) You testified that you were seeking to be found eligible for Medicaid since you cannot afford the premiums or co-pays associated with your Essential Plan.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (80 Fed. Reg. 3236, 3237).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (81 Fed. Reg. 4036).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Legal Analysis

The first issue under review is whether NYSOH properly determined that you were eligible for the Essential Plan, effective August 1, 2017

The redetermination of your eligibility on June 2, 2017 listed an annual household income of \$21,528.00, which consisted of \$414.00 you receive from your employment with [REDACTED]. You testified that this projected annual income and weekly income were accurate.

The eligibility determination relied upon that information.

You are in a one-person household. You expect to file your 2017 income taxes as single and will claim no dependents on that tax return.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income (MAGI) that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,880.00 for a one-person household. Since an annual household income of \$21,528.00 is 181.21% of the 2016 FPL, NYSOH properly found you to be eligible for the Essential Plan.

The second issue is whether NYSOH properly determined that you were not eligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$12,060.00 for a one-person household. Since \$21,528.00 is 178.51% of the 2017 FPL, NYSOH properly found you to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

You testified that your gross income during the month of the redetermination of your eligibility was \$1,656.00, consisting of four separate payments of \$414.00.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,387.00 per month. Since you credibly testified that you earned \$1,656.00 in June 2017 you do not qualify for Medicaid on the basis of monthly income as of the date of your application.

Since the June 3, 2017 eligibility determination properly stated that, based on the information you provided, you were eligible for the Essential Plan, and not eligible for Medicaid, it was correct and is AFFIRMED.

Decision

The June 3, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You remain eligible for the Essential Plan.

You are not eligible for Medicaid.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
