Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in a Medicaid Managed Care plan ended effective June 30, 2017?

Procedural History

On April 27, 2017, NYSOH issued an eligibility determination notice stating that you were eligible for Medicaid effective April 1, 2017.

Also on April 27, 2017, NYSOH issued a notice of enrollment confirming your enrollment in a Medicaid Managed Care plan, with a plan enrollment start date of June 1, 2017.

On June 15, 2017, NYSOH redetermined your household's eligibility for financial assistance with health insurance.

On June 16, 2017, NYSOH issued a notice of eligibility redetermination stating that you would remain eligible for Medicaid, effective July 1, 2017, however, you were unable to select a Medicaid Managed Care plan as the system was showing that you had other full benefit health insurance or Medicare.

On July 10, 2017, you uploaded a letter from United Healthcare – Oxford Plan showing that your coverage through them was cancelled as of May 31, 2017.

On July 13, 2017, NYSOH redetermined your eligibility and on that date you selected a Medicaid Managed Care plan for enrollment.

Also on July 13, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in your Medicaid Managed Care plan, insofar as your enrollment did not begin July 1, 2017.

On July 14, 2017, NYSOH issued an eligibility determination notice stating that you were eligible for Medicaid, effective July 1, 2017.

Also on July 14, 2017, NYSOH issued an enrollment confirmation notice stating that your enrollment in a Medicaid Managed Care plan would begin August 1, 2017.

On September 27, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified, and your account confirms, that you were determined eligible for Medicaid, effective April 1, 2017.
- 2) You testified that you subsequently selected a Medicaid Managed Care plan, effective June 1, 2017.
- 3) You testified, and your account confirms, that you did not receive a disenrollment notice advising you that you were disenrolled from your Medicaid Managed Care plan.
- 4) You testified that you went to the doctor during [REDACTED] of July 2017 and was advised that you were no longer enrolled in your United Healthcare Medicaid Managed Care plan, effective June 30, 2017.
- 5) You testified that you contacted NYSOH and was advised by a representative that you were disenrolled from your Medicaid Managed Care plan because the system determined that you had active third-party health insurance, effective June 30, 2017.
- 6) You testified that you had insurance through United Healthcare – Oxford Plan until May 31, 2017.

- 7) On July 10, 2017, you uploaded a letter from United Healthcare – Oxford Plan stating that you had coverage through them from January 1, 2017 through May 31, 2017.
- 8) The record indicates that the Third-Party Health Insurance was removed from the system on July 11, 2017.
- 9) You testified that you were without a Medicaid Managed Care plan during July 2017 and incurred medical bills.
- 10) The record does not contain any information from NYSOH regarding where they obtained the information that you were enrolled in third party health insurance.
- 11) The record indicates that you were reenrolled into a Medicaid Managed Care plan on August 1, 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if that individual was eligible at any time during that month (42 CFR § 435.915(b); Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010, 13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 18 NYCRR § 360-10.3(h);,; Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010, 13 ADM-03(III)(F)).

Continuous Coverage

Most applicants determined eligible for Medicaid are guaranteed 12 months of Medicaid coverage offered through Medicaid Managed Care, even if the adult loses Medicaid eligibility because of any changes or updates they make to their Marketplace account. For example, even if income increases above the Medicaid limit allowed for the household size, the insured will remain covered under Medicaid for a 12-month period. This 12-month period is referred to as

“continuous coverage,” and is set based on the start date of the original Medicaid eligibility determination or the date of any subsequent Medicaid eligibility determination based on modified adjusted gross income (see 42 CFR § 435.916; NY Social Services Law (NY SSL) § 366(4)(c)).

Third Party Health Insurance

A person who has primary medical or health care coverage available from or under a third-party insurance provider is not permitted to enroll into a Medicaid Managed Care plan (NY SSL § 364-j(3)(e)(xx); Medicaid Managed Care Model Contract (Appendix H-6), effective 3/1/2014 – 2/28/2019). However, they will remain eligible for fee-for-service Medicaid with limited exceptions, including entering prison or another facility that provides medical care, lack of state residence, or failing to provide a valid social security number (NY SSL § 366(4)(c)).

Legal Analysis

The issue for review is whether NYSOH properly determined that your enrollment in your Medicaid Managed Care plan ended effective June 30, 2017.

In the April 27, 2017 notice of eligibility determination, you were found eligible for Medicaid, effective April 1, 2017. On April 26, 2017, you selected a Medicaid Managed Care plan, effective June 1, 2017, as is documented by the April 27, 2017 notice of enrollment confirmation.

Generally, when an individual is eligible for Medicaid through NYSOH they are required to enroll in a Medicaid Managed Care plan. Applicants determined eligible will be enrolled or remain in their Medicaid plan with limited exceptions, including entering prison or another facility that provides medical care, moving out of state, or failing to provide a valid Social Security number.

On June 15, 2017, NYSOH redetermined your household's eligibility for financial assistance with health insurance. On June 16, 2017, NYSOH issued an eligibility determination notice advising that you remained eligible for Medicaid because you had full benefit health insurance or Medicare. The notice also stated that persons with other health insurance or Medicare cannot enroll in a Medicaid Managed Care plan.

When NYSOH determines that a person has active coverage in a health insurance plan outside of NYSOH, that person is not eligible to enroll or remain enrolled in a Medicaid Managed Care plan.

However, you credibly testified that your coverage under your employer-sponsored health insurance ended on May 31, 2017 and submitted

documentation from your employer-sponsored health insurance confirming that your coverage ended May 31, 2017.

Therefore, when NYSOH cancelled your coverage in a Medicaid Managed Care plan due to your having third party health insurance, you did not, in fact, have third party health insurance and the information relied upon by NYSOH in making the determination to terminate your coverage under your Medicaid Managed Care plan was incorrect.

Accordingly, the July 14, 2017 enrollment confirmation notice is MODIFIED to reflect that your coverage under your Medicaid Managed Care plan was effective July 1, 2017.

Decision

The July 14, 2017 enrollment confirmation notice is MODIFIED to reflect that your coverage under your Medicaid Managed Care plan was effective July 1, 2017.

Your case is RETURNED to NYSOH to reinstate your Medicaid Managed Care plan effective July 1, 2017.

How this Decision Affects Your Eligibility

NYSOH improperly disenrolled you from your Medicaid Managed Care plan.

Your case is being sent back to reinstate your Medicaid Managed Care plan as of July 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.
