NOTICE OF DISMISSAL – INVALID APPEAL REQUEST

Dear [REDACTED],

On July 17, 2017, you requested an appeal of the failure of NY State of Health (NYSOH) to allow you a special enrollment period in which to change your health plan. However, your appeal is currently not valid.

Why Your Appeal Request Is Not Valid

An applicant has the right to appeal to the Appeals Unit of NYSOH: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) a determination of eligibility for a special enrollment period; and (4) a failure by NYSOH to provide a timely notice of an eligibility determination (45 CFR §§ 155.505, 155.420(d)).

Your appeal was about your request for a special enrollment period. While this issue is one that is reviewable by the Appeals Unit of NYSOH, the Appeals Unit has no jurisdiction over such substantive issues until the first, formal determination has been issued by NYSOH.

Since no formal notice of determination has been issued, the Appeals Unit therefore does not have any authority to review your request for a special enrollment period.

What You Can Do Now

You may wish to submit a new application, making sure you have answered all questions regarding any qualifying life change events that might have a bearing on your eligibility for a special enrollment period.

NYSOH will then issue a formal response to your request for a special enrollment period, and you may appeal any such determination at that time.

How Does This Dismissal Affect Your Eligibility?

This decision does not change your current eligibility for or enrollment in a qualified health plan.

You may have additional options outside of the Appeals Unit of New York State of Health, such as through your plan or through the Department of Financial Services.

If You Think Your Appeal Should Not Be Dismissed

If you still think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. In that writing, you must explain why you think this dismissal should be vacated and if your issue differs from the one discussed above.

If you ask us in writing to vacate this dismissal, NYSOH's Appeals Unit will review your request and send you a decision on that request.

If we deny your request to vacate this dismissal, we will tell you that in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by NYSOH.
