Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Does the Appeals Unit of NY State of Health (NYSOH) have the authority to review the cancellation of coverage for your children for a purported non-payment of premiums?

Did NYSOH properly determine that your children's reenrollment in a Child Health Plus plan was effective September 1, 2017?

Procedural History

On December 7, 2016, NYSOH issued a notice of eligibility determination, stating that your children were eligible to enroll in a Child Health Plus plan, with a monthly premium of \$30.00 each, effective January 1, 2017.

On February 15, 2017, NYSOH issued an enrollment confirmation notice stating that your children were enrolled in a Child Health Plus plan, effective March 1, 2017.

On July 8, 2017, NYSOH issued a disenrollment notice stating that your children's coverage in their Child Health Plus plan ended effective June 30, 2017, because you did not pay your insurance bill by the payment deadline.

NYSOH records reflect that you updated your account and selected a Child Health Plus plan for your children on July 17, 2017. On that date, a preliminary eligibility determination was prepared with regard to that application, stating that

your children were eligible for a Child Health Plus plan, effective September 1, 2017.

Also on July 17, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your children's Child Health Plus plan insofar as it did not begin July 1, 2017.

On July 18, 2017, NYSOH issued a notice of enrollment, based on your plan selection on July 17, 2017, stating that your children were enrolled in a Child Health Plus plan effective September 1, 2017.

On October 10, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing your children's Child Health Plus plan disenrollment effective June 30, 2017 and their Child Health Plus plan re-enrollment date of September 1, 2017.
- 2) NYSOH records reflect that your children were enrolled in a Child Health Plus plan with an effective start date of March 1, 2017.
- 3) You testified that you received an invoice from your insurance carrier for July 2017 but that your premium payment was made late.
- 4) Your children were disenrolled from their Child Health Plus plan, effective July 1, 2017 for non-payment of premiums.
- 5) You submitted an application to NYSOH for financial assistance for your children and they were determined eligible for a Child Health Plus plan on July 17, 2017.
- 6) You testified, and NYSOH records reflect, that you enrolled your children into a Child Health Plus plan on July 17, 2017.
- 7) Your children's Child Health Plus plan start date was September 1, 2017.
- 8) You testified that you are seeking coverage for your children for the months of July 2017 and August 2017 because your children incurred medical expenses during those months.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Appealable Issues

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR § 155.505; and (4) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

Child Health Plus

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

"A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage" (42 CFR § 457.340(f)).

The State of New York has provided that a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The first issue under review is whether the Appeals Unit of NYSOH has the authority to review the cancellation of coverage for your children for a purported non-payment of premiums.

The Appeals Unit of NYSOH only has the authority to review issues related to the following: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (3) a failure by NYSOH to provide timely notice of an eligibility determination, and (4) a denial of a for a special enrollment period.

Because the Appeals Unit is not authorized to review termination of enrollment due to non-payment of premiums, we cannot reach the merits as to whether your children were properly terminated for nonpayment of premiums.

Therefore, your appeal of the July 8, 2017 disenrollment notice is **DISMISSED** as a non-appealable issue.

The second issue under review is whether NYSOH properly determined that your children's enrollment in a Child Health Plus plan was effective September 1, 2017.

You testified, and NYSOH records indicate, that you updated your NYSOH application on July 17, 2017. As a result, your children were found eligible for a Child Health Plus plan on July 17, 2017 and you selected a plan that day.

The date on which enrollment in a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

Therefore, the July 18, 2017 enrollment confirmation notice stating that your children's enrollment in a Child Health Plus plan was effective September 1, 2017, is correct and must be **AFFIRMED**.

Decision

The July 18, 2017 enrollment confirmation notice is **AFFIRMED**.

How this Decision Affects Your Eligibility

This decision does not change your children's eligibility.

The effective date of your children's Child Health Plus plan is September 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
