NOTICE OF DISMISSAL

On July 19, 2017, NY State of Health (NYSOH) issued an enrollment notice confirming that as of July 18, 2017, you were enrolled in an Essential Plan with an enrollment start date of September 1, 2017. You requested an appeal insofar as the enrollment start date of your health plan.

On September 6, 2017, a Hearing Officer from the NYSOH Appeals Unit contacted you for your scheduled telephone hearing. You stated that you were at work and unable to participate in the hearing at that time. NYSOH Appeals Unit returned your case to NYSOH to reschedule your telephone hearing.

On October 13, 2017, NYSOH issued a Notice of Telephone Hearing, advising you that the hearing you requested was rescheduled for November 7, 2017, at 10:00 am.

On November 7, 2017, a Hearing Officer from the NYSOH Appeals Unit contacted you for your scheduled telephone hearing. You stated that you were unavailable to participate in the hearing at that time. The Hearing Officer asked if there was a time that you would be able to participate in the hearing; however, you stated that you were unaware of such a time.

Based on the foregoing, we find that you were given notice of the formal hearing in writing and were unwilling to go forward with the appeal at the scheduled time.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NY State of Health will not review your appeal.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing, explain why you did not appear for your hearing as scheduled.

The NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
