NOTICE OF DISMISSAL

On July 22, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you and your spouse were eligible for an advance premium tax credit (APTC) of up to \$573.00 per month, effective September 1, 2017. You appealed this determination.

On September 7, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for October 4, 2017, at 11:00 a.m.

A Hearing Officer called you at 11:00 a.m. on October 4, 2017. Although you answered the call, you stated that you no longer wanted to proceed with the hearing since you had already found health insurance through a new employer beginning November 1, 2017. The Hearing Officer asked to place you under oath to obtain a formal withdrawal. You stated that you did not wish to be sworn in and requested that the hearing just be cancelled.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
