Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were eligible to receive up to \$143.00 per month in advance payments of the premium tax credit, effective August 1, 2017?

Procedural History

On October 18, 2016, NYSOH issued a renewal and eligibility determination notice stating that based on information contained in your application you submitted on September 22, 2016, you had been found eligible for an advance premium tax credit (APTC) of up to \$255.74 per month, effective January 1, 2017.

On November 26, 2016, NYSOH issued an enrollment notice confirming your enrollment in a qualified health plan (QHP) as of November 25, 2016. The notice stated that your monthly premium, after applying the APTC of \$255.74, would be \$271.64, with such coverage to begin effective January 1, 2017.

On July 12, 2017, you submitted an application for financial assistance, in which you attested to a change of address to:



On July 13, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to receive an APTC of up to \$143.00 per month, effective August 1, 2017.

Also on July 13, 2017, NYSOH issued an enrollment notice confirming your enrollment in your QHP as of July 12, 2017. The notice stated that your monthly premium, after applying the APTC of \$143.00, would be \$354.38, beginning August 1, 2017.

On July 28, 2017, you spoke to NYSOH's Account Review Unit and appealed the reduction of your APTC to \$143.00 as of August 1, 2017.

On October 11, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of single. You will claim no dependents on that tax return.
- 2) You are seeking insurance for yourself only.
- The application that was submitted on July 12, 2017 listed annual household income of \$40,560.00, consisting of \$19.50 per hour you receive from your employer, and the course of a 40-hour work week. You testified that this amount was correct.
- 4) Your application states that you will not be taking any deductions on your 2017 tax return.
- 5) You testified, and your NYSOH account reflects that you moved from testified that while you completed your move to your new address during March 2017, you did not reflect this in your NYSOH account until your July 12, 2017 application update.
- 6) You testified that you were seeking for your original APTC of \$255.74 to be reinstated as of August 1, 2017 since nothing in your account had changed, save for your change in address.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Advance Payments of Premium Tax Credit

Advance payments of the premium tax credit (APTC) are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

 the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2017 is set by federal law at 2.04% to 9.69% of household income (26 USC 36B(b)(3)(A), 26 CFR § 1.36B-3T(g)(1), IRS Rev. Proc.2016-24).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Federal Register 4036).

For annual household income in the range of at least 300% but less than 400% of the 2016 FPL, the expected contribution is 9.69% of the household income (26 CFR § 1.36B-3T(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2016-24).

People who use the APTC to help pay health insurance premiums must file a federal tax return and reconcile their expected income (stated on NYSOH

application) with their actual income (stated on their federal income tax return). Those who take less tax credit in advance than they claim on the tax return may get the rest of it as an income tax refund or have their tax bill reduced. Those who take more tax credit in advance than they can claim on their tax return will owe the difference as additional income taxes (26 CFR § 1.36B-4).

Legal Analysis

The issue is whether NYSOH properly determined that you were eligible for an APTC of \$143.00 per month, August 2017.

The application that was submitted on July 12, 2017 listed an annual household income of \$40,560.00 and the eligibility determination relied upon that information.

You are in a one-person household. You expect to file your 2017 income taxes as single and will claim no dependents on that tax return.

You testified, and your NYSOH account reflects, previously resided in , where the second lowest cost silver plan available for an individual through NYSOH costs \$564.84 per month.

You testified, and your NYSOH account reflects, that as of the date of your July 12, 2017 application, you reside in **Sector 19**, where the second lowest cost silver plan available for an individual through NYSOH costs \$470.85 per month.

An annual income of \$40,560.00 is 341.41% of the 2016 FPL for a one-person household. At 341.41% of the FPL, the expected contribution to the cost of the health insurance premium is 9.69% of income, or \$327.52 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual in your county (\$470.85 per month) minus your expected contribution (\$327.52 per month), which equals \$143.33 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you to be eligible for up to \$143.00 per month in APTC.

Since the July 13, 2017 eligibility determination notice properly stated that, based on the information you provided, you were eligible for up to \$143.00 per month in APTC beginning August 1, 2017, it is correct and is AFFIRMED.

Decision

The July 13, 2017 eligibility determination notice is AFFIRMED.

Effective Date of this Decision: October 16, 2017

How this Decision Affects Your Eligibility

You remain eligible for an APTC of up to \$143.00 per month, effective August 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
