lssue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you and your spouse did not qualify to enroll in a qualified health plan outside of the open enrollment period, effective September 1, 2017?

Procedural History

On July 31, 2017, NYSOH received your initial application for financial assistance. That day, a preliminary eligibility determination was prepared finding you and your spouse eligible to purchase a qualified health plan at full cost through NYSOH. You also attempted to enroll you and your spouse into a qualified health plan but were unable to select a plan for enrollment.

Also on July 31, 2017, you spoke to NYSOH's Account Review Unit and appealed your and your spouse's inability to enroll into a qualified health plan outside of the open enrollment period.

On August 1, 2017, NYSOH issued an eligibility determination notice stating that you and your spouse were eligible to purchase a qualified health plan at full cost through NYSOH, effective September 1, 2017. It further stated that you and your spouse did not qualify to select a health plan outside of the open enrollment period for 2017.

On October 12, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and held open to October 27, 2017, to allow you to submit supporting documents.

On October 16, 2017, you uploaded documentation regarding your COBRA plan election and subsequent termination. Those documents have been made part of the record collectively as Appellant's Exhibit # 1. The record was closed at that time.

Findings of Fact

A review of the record supports the following findings of fact:

- According to your NYSOH account and your testimony, on July 31, 2017, you submitted an application for health insurance for you and your spouse.
- According to your NYSOH account and your testimony on July 31, 2017, you attempted to enroll yourself and your spouse in a qualified health plan, but were unable to do so.
- 3) Your application on July 31, 2017 states that you and your spouse were seeking a special enrollment based on having lost minimum essential coverage on May 1, 2017.
- 4) On October 16, 2017, you uploaded to your NYSOH account documentation regarding your COBRA coverage
- 5) According to your NYSOH account, you and your spouse lost employer sponsored health insurance effective March 31, 2017.
- 6) According to your NYSOH account, you and your spouse enrolled in COBRA coverage effective April 1, 2017.
- According to your NYSOH account, your and your spouse's COBRA coverage was terminated effective May 1, 2017 due to failure to pay the May 2017 premium within the required timeframe.
- 8) You testified that you live part of the year in the state of but that you and your spouse are still New York State residents.
- 9) You testified that since filing your application on July 31, 2017, there have been no major changes to your household.

10)You testified that you did not rely on any statements made by NYSOH that prevented you in enrolling in a qualified health plan sooner.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Enrollment in a Qualified Health Plan

NYSOH must provide annual open enrollment periods during which time qualified individuals may enroll in a qualified health plan and enrollees may change qualified health plans (45 CFR § 155.410(a)(1)).

For the benefit year beginning on January 1, 2017, the annual open enrollment period began on November 1, 2016, and extended through January 31, 2017 (45 CFR § 155.410(e)(2)).

Special Enrollment Periods

After each open enrollment period ends, NYSOH provides special enrollment periods to qualified individuals. During a special enrollment period, a qualified individual may enroll in a qualified health plan, and an enrollee may change their enrollment to another plan. This is generally permitted when one of the following triggering events occur:

- (1) The qualified individual or his or her dependent either:
 - (i) Loses minimum essential coverage.

(ii) Is enrolled in any non-calendar year group health plan or individual health insurance coverage, even if the qualified individual or his or her dependent has the option to renew such coverage.

(iii) Loses pregnancy-related coverage.

(iv) Loses medically needy coverage as described under section 1902(a)(10)(C) of the Social Security Act only once per calendar year.

(2)(i) The qualified individual gains a dependent or becomes a dependent through marriage, birth, adoption, placement for adoption, or placement in foster care, or through a child support order or other court order.

(ii) the enrollee loses a dependent or is no longer considered a dependent through divorce or legal separation as defined by State law in the State in which the divorce or legal separation occurs, or if the enrollee, or his or her dependent, dies.

(3) The qualified individual, or his or her dependent, becomes newly eligible for enrollment in a qualified health plan because he or she gains citizenship, status as a national, or lawful present or is no longer incarcerated.

(4) The qualified individual's or his or her dependent's, enrollment or nonenrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities.

(5) The enrollee or, his or her dependent adequately demonstrates to NYSOH that the qualified health plan in which he or she is enrolled substantially violated a material provision of its contract in relation to the enrollee;

(6) The enrollee or enrollee's dependent is newly eligible or ineligible for advance payments of the premium tax credit, or change in eligibility for cost-sharing reductions.

(7) The qualified individual or enrollee, or his or her dependent, gains access to new qualified health plan as a result of a permanent move and either—

(i) Had minimum essential coverage for one or more days during the 60 days preceding the date of the permanent move, or

(ii) Was living outside of the United States or in a United States territory at the time of the permanent move;

(8) The qualified individual or dependent who gains or maintains status as an Indian may enroll in a qualified health plan or change from one plan to another, once per month.

(9) The qualified individual or enrollee, or his or her dependent, demonstrates to the Exchange, in accordance with guidelines issued by HHS, that the individual meets other exceptional circumstances as the Exchange may provide;

(10) A qualified individual or enrollee-

(i) Is a victim of domestic abuse or spousal abandonment, including a dependent or unmarried victim within a household, is enrolled in minimum essential coverage and seeks to enroll in coverage separate from the perpetrator of the abuse or abandonment; or

(ii) Is a dependent of a victim of domestic abuse or spousal abandonment, on the same application as the victim, may enroll in coverage at the same time as the victim;

(11) A qualified individual or dependent—

(i) Applies for coverage through NYSOH during the annual open enrollment period or due to a qualifying event, is assessed as potentially eligible for Medicaid or Child Health Plus and is determined ineligible for Medicaid or Child Health Plus either after open enrollment has ended or more than 60 days after the qualifying event; or

(ii) Applies for coverage at their Local Department of Social Services or Human Resources Administration during the annual open enrollment period, and is determined ineligible for Medicaid or Child Health Plus after open enrollment has ended;

(12) The qualified individual or enrollee, or his or her dependent, adequately demonstrates to NYSOH that a material error related to plan benefits, service area, or premium influenced the qualified individual's or enrollee's decision to purchase a qualified health plan; or

(13) At the option of NYSOH, the qualified individual provides satisfactory documentary evidence to verify his or her eligibility for an insurance affordability program or enrollment following termination of enrollment due to a failure to verify such status within 90 days. NYSOH has not elected to adopt this subsection at this time.

(45 CFR § 155.420(d)).

Generally, if a triggering life event occurs, the qualified individual or enrollee has 60 days from the date of a triggering event to select a qualified health plan (45 CFR § 155.420(c)(1)).

However, a loss of health insurance coverage such as that referenced above does not include,

"voluntary termination of coverage or other loss due to-

(1) Failure to pay premiums on a timely basis, including COBRA premiums prior to expiration of COBRA coverage, or

(2) Situations allowing for a rescission as specified in 45 CFR [§] 147.128" such as failure to comply with other requirements (45 CFR § 147.128(b))

(45 CFR § 155.420(e)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you and your spouse did not qualify to enroll in a qualified health plan outside of the open enrollment period, effective September 1, 2017.

NYSOH provided an open enrollment period from November 1, 2016 until January 31, 2017. On July 31, 2017, after the open enrollment period ended, you submitted an application for health insurance for you and your spouse and requested to enroll in a qualified health plan but were unable to do so. On August 1, 2017, NYSOH issued a notice stating that you and your spouse did not qualify to enroll in a qualified health plan outside of the open enrollment period.

Once the annual open enrollment period ends, a health plan enrollee must qualify for a special enrollment period in order to enroll in, or change to another health plan offered in NYSOH. In order to qualify for a special enrollment period, a person must experience a triggering event.

According to the record, your and your spouse's insurance coverage through your employer ended on March 31, 2017. You testified and the record reflects that you and your spouse enrolled in a COBRA health insurance plan with a plan start date of April 1, 2017. The record reflects that the COBRA plan terminated your and your spouse's coverage effective May 1, 2017 due to your non-payment of premium for the month of May 2017.

NYSOH considers loss of coverage due to non-payment of premium to be a voluntary action and not a triggering event. Therefore, your and your spouse's loss of COBRA health coverage effective May 1, 2017, cannot be considered a triggering event for a special enrollment period, because it was a result of non-payment of your COBRA premiums.

You testified that you live part of the year in the state of the but that you and your spouse are still New York State residents. You testified that there have been no changes to your household in 2017. As such, there is no evidence in the record to establish grounds for a special enrollment period on any other basis. The credible evidence of record indicates that, since the open enrollment period closed on January 31, 2017, no other triggering events have occurred that would qualify you and your spouse for a special enrollment period.

Therefore, NYSOH's August 1, 2017, denial of a special enrollment period to select a health plan outside of the open enrollment period for 2017 is AFFIRMED.

Decision

The August 1, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You and your spouse did not qualify for a special enrollment period as of September 1, 2017, and do not qualify at this time.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
