Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you do not qualify to enroll in a qualified health plan outside of the open enrollment period, effective September 1, 2017?

Procedural History

On November 28, 2016, you updated your application for health insurance.

On November 29, 2016, NYSOH issued a notice of eligibility determination, based on the November 28, 2016 application, stating that you were eligible to purchase a qualified health plan at full cost through NYSOH, effective January 1, 2017.

On December 14, 2016, NYSOH issued a notice of enrollment confirmation, based on your plan selection on December 13, 2016, stating that you were enrolled in an Oscar qualified health plan, effective January 1, 2017.

On January 26, 2017, NYSOH issued a notice of change in mailing address, stating that your address had been updated to [REDACTED]

Also on January 26, 2017, NYSOH issued a notice of enrollment confirmation stating that you were enrolled in an Oscar qualified health plan, effective January 1, 2017. This notice was mailed to your new address.

On August 1, 2017, NYSOH received your application for health insurance. That day, a preliminary eligibility determination was prepared stating that you were eligible to purchase a qualified health plan at full cost through, effective September 1, 2017. You also attempted to enroll into a qualified health plan but were unable to select a plan for enrollment.

Also on August 1, 2017, you spoke to NYSOH's Account Review Unit and appealed your inability to enroll into a qualified health plan outside of the open enrollment period.

On August 2, 2017, NYSOH issued an eligibility determination notice, based on the August 1, 2017 application, stating that you were eligible to purchase a qualified health plan at full cost, effective September 1, 2017. It further stated that you do not qualify to select a health plan outside of the open enrollment period for 2017.

Also on August 2, 2017, NYSOH issued a disenrollment notice stating that your coverage with your Oscar qualified health plan would end on August 31, 2017. This was because you had moved to another county.

On October 13, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) On November 28, 2016 you submitted an application for health insurance.
- 2) You testified that when you first applied for coverage for 2017 you were living in [REDACTED], NY.
- 3) You testified that in January 2017 you moved to [REDACTED], NY.
- 4) You testified that you did not know that there was an issue with your coverage until August 2017 when you attempted to schedule a doctor's appointment. You explained that when you contacted your insurance company, they advised you that you could no longer have coverage with Oscar because you were no longer within the Oscar service area.
- 5) You testified that your Oscar coverage ended on August 31, 2017 and you are seeking a special enrollment period to be able to reenroll in coverage outside of the open enrollment period in 2017.

- 6) The events tab within NYSOH account reflects that on January 25, 2017 username [REDACTED] updated your address to reflect that you had moved counties.
- 7) You testified that your username for NYSOH is [REDACTED].
- 8) You testified that in addition to appealing because you would like to enroll in a plan for the remainder of 2017, you are also appealing because you do not want to be responsible for a tax penalty when you file your 2017 tax return for being without coverage.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Enrollment in a Qualified Health Plan

NYSOH must provide annual open enrollment periods during which time qualified individuals may enroll in a qualified health plan and enrollees may change qualified health plans (45 CFR § 155.410(a)(1)).

For the benefit year beginning on January 1, 2017, the annual open enrollment period began on November 1, 2016, and extended through January 31, 2017 (45 CFR § 155.410(e)(2)).

Special Enrollment Periods

After each open enrollment period ends, NYSOH provides special enrollment periods to qualified individuals. During a special enrollment period, a qualified individual may enroll in a qualified health plan, and an enrollee may change their enrollment to another plan. This is generally permitted when one of the following triggering events occur:

- (1) The qualified individual or his or her dependent either:
 - (i) Loses minimum essential coverage.
 - (ii) Is enrolled in any non-calendar year group health plan or individual health insurance coverage, even if the qualified individual or his or her dependent has the option to renew such coverage.
 - (iii) Loses pregnancy-related coverage.

(iv) Loses medically needy coverage as described under section 1902(a)(10)(C) of the Social Security Act only once per calendar year.

(2)(i) The qualified individual gains a dependent or becomes a dependent through marriage, birth, adoption, placement for adoption, or placement in foster care, or through a child support order or other court order.

(ii) the enrollee loses a dependent or is no longer considered a dependent through divorce or legal separation as defined by State law in the State in which the divorce or legal separation occurs, or if the enrollee, or his or her dependent, dies.

(3) The qualified individual, or his or her dependent, becomes newly eligible for enrollment in a qualified health plan because he or she gains citizenship, status as a national, or lawful present or is no longer incarcerated.

(4) The qualified individual's or his or her dependent's, enrollment or non-enrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities.

(5) The enrollee or, his or her dependent adequately demonstrates to NYSOH that the qualified health plan in which he or she is enrolled substantially violated a material provision of its contract in relation to the enrollee;

(6) The enrollee or enrollee's dependent is newly eligible or ineligible for advance payments of the premium tax credit, or change in eligibility for cost-sharing reductions.

(7) The qualified individual or enrollee, or his or her dependent, gains access to new qualified health plan as a result of a permanent move and either—

(i) Had minimum essential coverage for one or more days during the 60 days preceding the date of the permanent move, or

(ii) Was living outside of the United States or in a United States territory at the time of the permanent move;

(8) The qualified individual or dependent who gains or maintains status as an Indian may enroll in a qualified health plan or change from one plan to another, once per month.

(9) The qualified individual or enrollee, or his or her dependent, demonstrates to the Exchange, in accordance with guidelines issued by HHS, that the individual meets other exceptional circumstances as the Exchange may provide;

(10) A qualified individual or enrollee—

(i) Is a victim of domestic abuse or spousal abandonment, including a dependent or unmarried victim within a household, is enrolled in minimum essential coverage and seeks to enroll in coverage separate from the perpetrator of the abuse or abandonment; or

(ii) Is a dependent of a victim of domestic abuse or spousal abandonment, on the same application as the victim, may enroll in coverage at the same time as the victim;

(11) A qualified individual or dependent—

(i) Applies for coverage through NYSOH during the annual open enrollment period or due to a qualifying event, is assessed as potentially eligible for Medicaid or Child Health Plus and is determined ineligible for Medicaid or Child Health Plus either after open enrollment has ended or more than 60 days after the qualifying event; or

(ii) Applies for coverage at their Local Department of Social Services or Human Resources Administration during the annual open enrollment period, and is determined ineligible for Medicaid or Child Health Plus after open enrollment has ended;

(12) The qualified individual or enrollee, or his or her dependent, adequately demonstrates to NYSOH that a material error related to plan benefits, service area, or premium influenced the qualified individual's or enrollee's decision to purchase a qualified health plan; or

(13) At the option of NYSOH, the qualified individual provides satisfactory documentary evidence to verify his or her eligibility for an insurance affordability program or enrollment following termination of enrollment due to a failure to verify such status within 90 days.

(45 CFR § 155.420(d)).

Generally, if a triggering life event occurs, the qualified individual or enrollee has 60 days from the date of a triggering event to select a qualified health plan (45 CFR § 155.420(c)(1)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you do not qualify to enroll in a qualified health plan outside of the open enrollment period, effective September 1, 2017.

NYSOH provided an open enrollment period from November 1, 2016 until January 31, 2017. On November 29, 2016 you submitted an application for health insurance and on December 13, 2016 requested to enroll in a qualified health plan.

On January 25, 2017, you updated your address in your NYSOH account.

On August 1, 2017, you contacted NYSOH and attempted to change health plans because you had been disenrolled from your Oscar qualified health plan as you had moved counties.

On August 2, 2017, NYSOH issued a disenrollment notice stating that your enrollment in your Oscar qualified health plan was ending on August 31, 2017 because you had moved counties.

Also on August 2, 2017, NYSOH issued a notice stating that you do not qualify to enroll in a qualified health plan outside of the open enrollment period.

Once the annual open enrollment period ends, a health plan enrollee must qualify for a special enrollment period in order to enroll in, or change to another health plan offered in NYSOH. In order to qualify for a special enrollment period, a person must experience a triggering event.

A special enrollment period can be granted if a qualified individual's enrollment or non-enrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities.

The record reflects that on January 25, 2017, you updated your NYSOH account to reflect that you had moved counties. On January 26, 2017, a change in address notice was issued in response to this update as well as a new enrollment notice reflecting that you remained enrolled in your Oscar qualified health plan.

Had NYSOH issued a disenrollment notice at that time, advising you that you were being disenrolled from your Oscar qualified health plan because you had moved counties, you would have been able to reenroll in a different qualified health plan at that time.

Since the record indicates that your non-enrollment into a qualified health plan was the direct result of an error by NYSOH, you should have been granted a special enrollment period as of your August 1, 2017 application.

Therefore, NYSOH's August 2, 2017 eligibility determination that you do not qualify to select a health plan outside of the open enrollment period for 2017 is MODIFIED to reflect that you are eligible for a special enrollment period as of the date of your August 1, 2017 application.

Your case is RETURNED to NYSOH to assist you in enrolling into a qualified health plan. You may choose to enroll into a qualified health plan as of September 1, 2017 because NYSOH made an error. In the alternative, you may elect to enroll into coverage within 60 days from the date of this decision.

NYSOH's failure to grant you a special enrollment period resulted in you being without insurance coverage for part of the 2017 coverage year. During the hearing, you testified that you are concerned about receiving a tax penalty as a result of being without coverage.

Sometimes after an appeal decision, an appellant can claim an exemption from the requirement to have health insurance. You might qualify for a health coverage exemption in 2017 if you did not have health coverage while you were waiting for an appeal decision about coverage eligibility or savings and your appeal was eventually successful.

You must claim this exemption through the United States Department of Health and Human Services (HHS). Currently, NYSOH does not accept hardship exemption applications.

Important: If you do not get a response from HHS to your exemption application in time to file your tax return, write the word "pending" in column "c" and file your return. If HHS does not approve your exemption, you will need to file an amended return later.

Decision

The August 2, 2017 eligibility determination that you do not qualify to select a health plan outside of the open enrollment period for 2017 is MODIFIED to reflect that you are eligible for a special enrollment period as of the date of your August 1, 2017 application.

Your case is RETURNED to NYSOH to assist you in enrolling into a qualified health plan. You may choose to enroll into a qualified health plan as of September 1, 2017, if so choose. In the alternative, you may elect to enroll into coverage within 60 days from the date of this decision. You will be responsible for premium payments for any months you are enrolled into coverage.

How this Decision Affects Your Eligibility

NYSOH improperly denied you a special enrollment period.

Your case is being sent back to NYSOH to allow you to enroll into coverage as of September 1, 2017, if you so choose. In the alternative, you may elect to enroll into coverage within 60 days from the date of this decision.

You will be responsible for any premium payments for any months you are enrolled into coverage.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
