Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible to enroll in an Essential Plan with a \$0.00 monthly premium?

Did NYSOH properly determine that you were not eligible for Medicaid?

Procedural History

On July 14, 2017, you updated your application for financial assistance.

On July 15, 2017, NYSOH issued an eligibility determination notice, based on the application submitted on July 14, 2017, stating that you were eligible to enroll in an Essential Plan, with a \$0.00 monthly premium, effective August 1, 2017.

Also on July 15, 2017, NYSOH issued an enrollment notice confirming stating that you were enrolled in an Essential Plan with a \$0.00 monthly premium, effective August 1, 2017.

On August 1, 2017, you spoke to NYSOH's Account Review Unit and appealed that determination insofar as you were not eligible for Medicaid.

On October 24, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. During the hearing, your spouse acted as your Authorized Representative and assisted you with your testimony. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) On July 14, 2017, you updated your application, attesting to a household income of \$23,304.00. The income consists of \$14,304.00 you receive annually in Social Security disability benefits and \$9,000.00 your spouse receives annually in Social Security benefits. Your authorized representative testified that these amounts were correct.
- 2) The July 14, 2017 application stated that you did not plan on filing a federal tax return for 2017. Your Authorized Representative testified that you and she (your spouse) live together and have no dependents.
- 3) According to your account, NYSOH determined your eligibility based on a two-person household.
- 4) Based on the updated income information in the July 14, 2017 application, NYSOH determined you eligible for the Essential Plan with a \$0.00 premium payment.
- 5) You appealed that determination insofar as you were not eligible for Medicaid.
- 6) Your application states that you live in Erie County.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$16,020.00 for a two-person household (81 Federal Register 4036).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$16,240.00 for a two-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Legal Analysis

The first issue is whether NYSOH properly determined you were eligible to enroll in an Essential Plan with a \$0.00 monthly premium.

On July 14, 2017, you updated your application attesting to a household income of \$23,304.00. Your Authorized Representative testified this information was accurate and the eligibility determination relied upon that information.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. Your Authorized Representative testified that you and she (your spouse) live together and have no dependents. Thus, for the purposes of determining your eligibility for health insurance through NYSOH, you and your spouse are deemed to be in a two-person household.

On the date of your July 14, 2017 application, the relevant FPL was \$16,020.00 for a two-person household. Since an annual household income of \$23,304.00 is 145.46% of the 2016 FPL, which is between 138% and 200% of the FPL, NYSOH properly found you to be eligible for the Essential Plan with a \$0.00 monthly premium.

The second issue is whether NYSOH properly determined that you were ineligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$16,240.00 for a two-person household. Since the household income amount of \$23,304.00, as attested to in the July 14, 2017 application, is 143.49% of the 2017 FPL, NYSOH properly found you ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

You testified, and NYSOH records reflect that you earned \$1,942.00 for the month of July 2017. As such, you do not qualify for Medicaid based on monthly income, because such income is over the allowable monthly limit of \$1,868.00 (138% of the 2017 FPL).

Since the July 15, 2017 eligibility determination properly stated that, based on the information you provided, you were eligible to enroll in the Essential Plan with a \$0.00 monthly premium and, thus, you were not eligible for Medicaid, it is correct and is AFFIRMED.

Decision

The July 15, 2017 eligibility determination is AFFIRMED.

Effective Date of this Decision: November 3, 2017

How this Decision Affects Your Eligibility

You remain eligible for the Essential Plan with no monthly premium.

You are not eligible for Medicaid.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
