Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your spouse's enrollment in an Essential Plan was effective September 1, 2017?

Procedural History

On August 1, 2017, you submitted an application for financial assistance with health insurance. That day, a preliminary determination was prepared, stating that you and your spouse were eligible for the Essential Plan effective September 1, 2017.

Also on August 1, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your spouse's enrollment in the Essential insofar as it did not begin on August 1, 2017.

On August 2, 2017, NYSOH issued a notice of eligibility determination, based on your August 1, 2017 application, stating that you and your spouse were eligible to enroll in the Essential Plan, effective September 1, 2017.

Also on August 2, 2017, NYSOH issued a notice of enrollment, based on your plan selection on August 1, 2017, stating that you and your spouse were enrolled in an Essential Plan, and that your plan would start September 1, 2017.

On October 19, 2017, you and your spouse had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on August 1, 2017.
- 2) You testified, and the record reflects, that your spouse was enrolled in an Essential Plan on August 1, 2017 with a start date of September 1, 2017.
- 3) You testified that you wanted your spouse's enrollment in an Essential Plan to begin on August 1, 2017 because he has outstanding medical bills.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see *also* 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue is whether NYSOH properly determined that your spouse's enrollment in the Essential Plan was effective September 1, 2017.

You testified, and the record indicates, that you updated your NYSOH application on August 1, 2017. As a result, your spouse was found eligible for the Essential Plan as of September 1, 2017 and enrolled into a plan that day.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On August 1, 2017, you selected an Essential Plan, so your spouse's enrollment properly took effect on the first day of the first month following August 1, 2017; that is, on September 1, 2017.

Therefore, the August 2, 2017 enrollment confirmation notice stating that your spouse's enrollment in the Essential Plan was effective September 1, 2017, is correct and must be AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your spouse's eligibility.

The effective date of your spouse's Essential Health Plan is September 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
