Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your child's enrollment in her Child Health Plus plan was effective September 1, 2017?

Procedural History

On July 20, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, based on your July 19, 2017 application, stating that your child was eligible to enroll in Child Health Plus with a \$30.00 monthly premium, effective September 1, 2017.

Also on July 20, 2017, NYSOH issued a notice of enrollment, based on your plan selection on July 19, 2017, stating that your child was enrolled in a Child Health Plus plan, and that this enrollment in the plan would start September 1, 2017.

On August 3, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your child's Child Health Plus plan insofar as it did not begin July 1, 2017.

On October 13, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing only your child's enrollment start date.
- 2) You first submitted an application to NYSOH for financial assistance on behalf of your child on July 19, 2017.
- 3) You testified, and the record reflects, that you enrolled your child into a Child Health Plus plan on July 19, 2017.
- 4) You testified that you need your child's Child Health Plus plan to begin on July 1, 2017 because that is the month she lost her insurance under her father's employer sponsored insurance.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

"A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage" (42 CFR § 457.340(f)).

The State of New York has provided that a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue is whether NYSOH properly determined that your child's enrollment in her Child Health Plus plan was effective September 1, 2017.

You first submitted an application to NYSOH for financial assistance on behalf of your child on July 19, 2017 and enrolled her into a Child Health Plus plan that day.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since you enrolled your child on July 19, 2017, her coverage would not go into effect until the first day of the second month following July, that is on September 1, 2017.

Therefore, the July 20, 2017 enrollment confirmation notice stating that your child's enrollment in her Child Health Plus plan was effective September 1, 2017, is correct and must be AFFIRMED.

Decision

The July 20, 2017 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your child's eligibility.

The effective date of your child's Child Health Plus plan is September 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
