NOTICE OF DISMISSAL – FAILURE TO APPEAR

On August 4, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you and your spouse were eligible to enroll in the Essential plan with a \$20.00 monthly premium, effective September 1, 2017. You appealed this determination insofar as you were seeking a reinstatement of your Medicaid coverage.

On October 13, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for November 6, 2017, at 11:00 a.m.

On November 6, 2017, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH. On the first attempt at 11:00 a.m., the Hearing Officer could not reach you and was forced to leave a voicemail. On the second attempt at 11:15 a.m., an individual answered the call and stated that you were not available, but would be available shortly and to call back. On the third attempt at 11:28 a.m., the same individual answered again and stated that she would be getting you on the phone, but after a long duration on hold the call appeared to have been disconnected or dropped. Accordingly, we were unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
