Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible for the Essential Plan, effective September 1, 2017?

Did NYSOH properly determine that you were not eligible for Medicaid?

Procedural History

On August 4, 2017, you updated your application for financial assistance. That day, a preliminary eligibility determination was prepared stating that were eligible to enroll in the Essential Plan, effective September 1, 2017.

Also on August 4, 2017, you spoke to NYSOH's Account Review Unit and appealed insofar as you were not found eligible for Medicaid. You were found eligible for "Aid to Continue" during the pendency of the appeal, so you were reenrolled in Medicaid for a limited time.

On August 5, 2017, NYSOH issued an eligibility determination notice based on the August 4, 2017 application, stating that you are eligible to enroll in the Essential Plan, effective September 1, 2017. It further stated that you were not eligible for Medicaid since your income was over the allowable income limit for that program.

On October 18, 2017, your Authorized Representative, [REDACTED], had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The

record was developed during the hearing and remained open as the Hearing Officer directed you to provide as additional evidence to corroborate your testimony: all earnings statements you received from your employer, [REDACTED] during month of August 2017. The record was to be closed 15 days after the hearing date, or upon the receipt of the above referenced documents, whichever occurred earlier.

On October 18, 2017, you provided to NYSOH Appeals Unit five earnings statements issued to you by your employer between August 3, 2017 and August 31, 2017.

Accordingly, the record was closed on October 18, 2017.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you wanted [REDACTED], to act as your Authorized Representative during the hearing.
- 2) Your August 4, 2017 application reflects that you expect to file your 2017 taxes with a tax filing status of single, and that you will not claim any dependents on your tax return.
- 3) Your Authorized Representative testified that you anticipate claiming at least two dependents on your tax return; however, you are the only person listed in your account since its inception.
- 4) You are seeking insurance for yourself only.
- 5) The application that was submitted on August 4, 2017 listed annual household income of \$22,880.00, consisting of \$11.00 per hour you earn from your employer over a 40-hour work week. Your Authorized Representative stated that those figures were reasonably accurate.
- 6) Your application states that you will not be taking any deductions on your tax return.
- 7) You live in [REDACTED] New York.
- 8) Your Authorized Representative stated that the Essential Plan that you had been found eligible for was not affordable, and that you wanted to be found eligible for Medicaid.

- 9) On October 18, 2017, you provided to NYSOH five earnings statements reflecting that you received \$363.00 on August 3, 2017, August 10, 2017, August 17, 2017, August 24, 2017 and August 31, 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Federal Register 4036).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the

applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Legal Analysis

The first issue under review is whether NYSOH properly determined that you were eligible for the Essential Plan, effective September 1, 2017

The application that was submitted on August 4, 2017 listed an annual household income of \$22,880.00, consisting of \$11.00 per hour you earn from your employer over a 40-hour work week. The eligibility determination relied upon that information.

According to your application, you are in a one-person household, and you expect to file your 2017 income taxes as single and will claim no dependents on that tax return. Although your Authorized Representative stated that you planned to claim two of your children as dependents on your tax return, we do not find such testimony credible since every application you submitted to NYSOH from January 23, 2014 to August 4, 2017 reflected that you anticipated filing as single and claiming no dependents. Furthermore, no person, other than yourself, has ever been included within your NYSOH account. Therefore, the Appeals Unit finds that your eligibility must be determined based on a one-person household.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income (MAGI) that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,800.00 for a one-person household. Since an annual household income of \$22,880.00 is 192.59% of the 2016 FPL, NYSOH properly found you to be eligible for the Essential Plan.

The second issue is whether NYSOH properly determined that you were not eligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified

adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$12,060.00 for a one-person household. Since \$22,880.00 is 189.72% of the 2017 FPL, NYSOH properly found you to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

On October 18, 2017, at the request of the Hearing Officer, you provided to NYSOH five earnings statements reflecting that you received \$363.00 on August 3, 2017, August 10, 2017, August 17, 2017, August 24, 2017 and August 31, 2017. Accordingly, your total income received during the month of your application, August 2017, was \$1,815.00.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,387.00 per month. Since the documentation you provided shows that you earned \$1,815.00 in August 2017, you do not qualify for Medicaid based on monthly income as of the date of your application.

Since the August 5, 2017 eligibility determination notice properly stated that, based on the information you provided, you were eligible for the Essential Plan, and not eligible for Medicaid, it was correct and is AFFIRMED.

Decision

The August 5, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You remain eligible for the Essential Plan.

You are not eligible for Medicaid, and your limited enrollment in that coverage will end.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
