## NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On July 20, 2017, NY State of Health (NYSOH) issued an enrollment, stating that your qualified health plan (QHP) coverage would begin effective July 1, 2017. You appealed that determination insofar as you were seeking a start date of August 1, 2017.

On September 5, 2017, NYSOH issued a disenrollment notice confirming that your QHP coverage under Fidelis Care Bronze ST INN Pediatric Dental Dep25 ended on July 31, 2017 due to non-payment of premium.

On October 20, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because you were no longer seeking a reinstatement of your QHP coverage through Fidelis Care as of August 1, 2017, but rather seeking for premiums you paid for coverage during August, September and October 2017 to be returned by Fidelis Care. You further stated that you would follow up with Fidelis Care directly to have these premiums reimbursed to you rather than continue with the appeal through NYSOH.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
