Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your eligibility for and enrollment in a qualified health plan were effective no earlier than August 1, 2017?

Procedural History

On July 7, 2017, you submitted an application for health insurance in which you indicated that you were pregnant.

On July 8, 2017, NYSOH issued a notice of eligibility determination stating that you were newly eligible to purchase a qualified health plan at full cost, effective August 1, 2017.

Also on July 8, 2017, NYSOH issued an enrollment confirmation notice, stating that you were enrolled in a qualified health plan, effective August 1, 2017.

On August 8, 2017, you spoke to NYSOH's Account Review Unit and appealed the eligibility determination and enrollment confirmation notices insofar as they began your eligibility for and enrollment in a qualified health plan on August 1, 2017, and not July 1, 2017.

On October 19, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record support the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on July 7, 2017.
- 2) Your July 7, 2017 application states that you were pregnant and expecting one child with a due date of [REDACTED].
- 3) You testified that you found out you were pregnant in late June 2017.
- 4) You testified, and the record reflects, that you selected a qualified health plan on July 7, 2017.
- 5) Your enrollment in the plan became effective August 1, 2017.
- 6) You testified that you need your qualified health plan and eligibility for financial assistance to begin on July 1, 2017 because you have outstanding medical bills for services rendered in July 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Redetermination During a Benefit Year

When a redetermination is issued as a result of a change in an applicant's information, NYSOH must generally make that redetermination effective on the first day of the month following the date NYSOH is notified of the change (45 CFR § 155.330 (f)(1)(ii)). However, NYSOH may determine that its policy will be that any change made after the 15th of any month will not be effective until the first of the second following month (45 CFR § 155.330(f)(2)).

When an eligibility redetermination results in a change in the amount of advance payments of the premium tax credit (APTC) for the benefit year, NYSOH must recalculate the amount of APTC in such a manner as to account for any advance payments already made on behalf of the tax filer, such that the recalculated advance payment amount is projected to result in total advance payments for the benefit year that correspond to the tax filer's total projected premium tax credit for that benefit year (45 CFR § 155.330(g)).

Enrollment in a Qualified Health Plan- Pregnant Individuals

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

A pregnant individual may enroll at any time after a licensed health care professional certifies that the individual is pregnant. The effective date of coverage is the first day of the month in which the individual is certified pregnant, unless the individual elects to have coverage begin the first day of the month following the date that the individual is certified pregnant (NY INS §4328(b)(4)(B)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your eligibility for and enrollment in a qualified health plan was effective no earlier than August 1, 2017.

The record reflects that on July 7, 2017, you updated the information in your NYSOH account and submitted a request to enroll in a qualified health plan. On July 8, 2017, NYSOH issued an eligibility determination notice and an enrollment confirmation notice stating that your eligibility for and enrollment in a qualified health plan was effective August 1, 2017. You are seeking coverage effective July 1, 2017 due to outstanding medical bills for services rendered in July 2017.

Generally, when an individual changes information in their application on or before the 15th of any month, NYSOH must make the redetermination that results from the change effective the first day of the following month. Additionally, the date on which a qualified health plan can take effect depends on the day a person selects the plan for enrollment. Generally, a plan that is selected from the first day to and including fifteenth day of a month goes into effect on the first day of the following month.

However, the effective date of coverage for a pregnant individual is the first day of the month in which the individual is certified pregnant, or the first day of the month following the date that the individual is certified pregnant. You credibly testified that you found out you were pregnant in late June 2017, and updated your application on July 7, 2017 to include that information.

Since you found out you were pregnant in June 2017, the first day of the next month following June 2017 would be July 1, 2017, which is the date that you requested enrollment to begin. Therefore, based on the date you found out you were pregnant and your pregnancy status at the time of your July 7, 2017 application, you should have been determined eligible for and enrolled in a qualified health plan effective July 1, 2017.

Therefore, NYSOH's July 8, 2017 eligibility determination notice and enrollment confirmation notice are MODIFIED to state that your eligibility for and enrollment in a qualified health plan is effective July 1, 2017. Your case is RETURNED to NYSOH to enroll you into your qualified health plan as of July 1, 2017.

Decision

The July 8, 2017 eligibility determination notice is MODIFIED to state that you were eligible to purchase a qualified health plan at full cost, effective July 1, 2017.

The July 8, 2017 enrollment confirmation notice is MODIFIED to state that your enrollment in your qualified health plan is effective July 1, 2017.

Your case is RETURNED to NYSOH to enroll you into your qualified health plan as of July 1, 2017.

How this Decision Affects Your Eligibility

Your eligibility for and enrollment in a qualified health plan should have begun on July 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.
