Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that you were not eligible for advance payments of the premium tax credit or cost-sharing reductions, effective September 1, 2017?

Procedural History

On August 8, 2017, NY State of Health (NYSOH) received your application for health insurance. That day, a preliminary eligibility determination was prepared finding you eligible to enroll in a qualified health plan; however, you were not eligible for advance premium tax credits (APTC) or cost-sharing reductions.

Also on August 8, 2017, you contacted NYSOH's Account Review Unit and requested an appeal of that preliminary eligibility determination as it related to the termination of your financial assistance.

On August 9, 2017, NYSOH issued an eligibility determination notice, based on the information contained in the August 8, 2017 application, stating you were eligible to purchase a qualified health plan at full cost beginning September 1, 2017. It stated that you do not qualify for APTC and cost-sharing reductions because your application states that the primary tax filers in your household are married but not filing taxes jointly.

On October 25, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) According to your NYSOH account, you will be filing your 2017 income tax return with a tax filing status of married filing separately. You will claim no dependents on that income tax return.
- 2) You testified that you are unsure of how you will be filing your income tax return in 2017, but believed it would be with a tax filing status of married filing separately.
- 3) You testified that you have no children.
- 4) You testified that you are currently married as of June 2017, reside with your spouse, and that you do not plan to legally separate from or divorce your spouse.
- 5) According to your NYSOH account and your testimony, you live in [REDACTED], New York.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Advance Payments of the Premium Tax Credit

APTC is available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable poverty level (FPL) (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

Additionally, a tax filer who is married must file a joint return with his or her spouse to qualify for APTC (45 CFR §§ 155.305(f), 155.310(d); 26 CFR § 1.36B-2).

However, an individual will be treated as not married at the close of the taxable year if the individual

- 1) Is legally separated from his/her spouse under a decree of divorce or of separate maintenance, or
- 2) Meets all of the following criteria:
 - a. files a separate return from his/her spouse and maintains his/her household as the primary home for a qualifying child;
 - b. pays more than one half of the cost of keeping up his/her home for the tax year; and
 - c. does not have his/her spouse as a member of the household during the last 6 months of the tax year

(26 USC § 7703).

Cost-Sharing Reductions

Cost-sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you are not eligible for APTC and cost-sharing reductions.

In the eligibility determination notice issued on August 9, 2017, NYSOH denied APTC because you indicated that you were married but did not plan to file a joint federal income tax return.

To qualify for APTC, a person who is married must either file taxes jointly with his or her spouse or qualify as “not married” at the close of the tax year.

According to the information in the record and your testimony at the hearing, you are still married to your spouse and have not obtained a decree of divorce or of separate maintenance. Although you testified that you were unsure whether you would file married filing separately in 2017, the application you submitted on August 8, 2017 indicates that you plan on filing your tax return with a tax status of

married filing separately in 2017. Since the evidence of record is the most credible, it is concluded that you do not plan to file a joint federal income tax return with your spouse for the 2017 tax year.

There is an exception, as noted above, that allows a tax filer to be treated as “not married” at the close of a taxable year, making the tax filer eligible for APTC. However, the record does not support a finding that you meet the necessary requirements for that exception.

Therefore, NYSOH was correct when it found that you were not eligible for APTC due to your tax filing status.

Cost-sharing reductions are available only to those who meet the requirements for APTC. Since you did not qualify for APTC, NYSOH correctly found that you were not eligible for cost-sharing reductions.

Since NYSOH correctly determined that you are not eligible for APTC or cost-sharing reductions, the August 9, 2017 notice of eligibility determination is **AFFIRMED**.

Decision

The August 9, 2017 eligibility determination notice is **AFFIRMED**.

How this Decision Affects Your Eligibility

You remain eligible to purchase a qualified health plan at full cost through New York State of Health.

You remain ineligible for an APTC because you are married but not filing your 2017 federal income tax return jointly.

You remain ineligible for cost-sharing reductions because you are not eligible for an advance premium tax credit.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
