## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were not eligible for Medicaid for October 2016?

## Procedural History

On December 15, 2016, you submitted an application for financial assistance with health insurance and indicated that you were seeking help for paying for medical bills for the prior three months.

On December 16, 2016, NYSOH issued a notice of eligibility determination stating that you were eligible for retroactive Medicaid for November 2016. The notice further directed you to provide proof of household income for September 2016 and October 2016 by December 30, 2016.

On August 9, 2017, you spoke to NYSOH's Account Review Unit and filed an appeal insofar as you had not been determined eligible for retroactive Medicaid for October 2016.

On September 5, 2017, NYSOH issued an eligibility determination notice stating that you were not eligible for Medicaid for October 2016 because you did not provide proof of household income.

On December 13, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing held open up to December 29, 2017, to allow you time to submit supporting documents.

On January 2, 2018, one business day after the deadline, NYSOH received documentation. As it was received the day following a holiday, the documentation will be considered and it was incorporated into the record as Appellant's Exhibit #1. The record was closed that day.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking Medicaid for October 2016.
- 2) You testified that you filed your 2016 federal income tax return as married filing jointly, and claimed four dependents.
- 3) You submitted an application for financial assistance on December 15, 2016.
- 4) Your application submitted on December 15, 2016, states that for the month of October 2016 your income was \$800.00. You testified that you earned about \$500.00 in October 2016.
- 5) You testified that you are paid bi-weekly.
- 6) You submitted a paystub dated November 10, 2016 for a gross pay amount of \$540.00.
- 7) You submitted an IRS tax transcript for 2016, which states that your household's adjusted gross income for 2016 was \$13,739.00.
- 8) You submitted a paystub report for your spouse from 2016, which states that he earned \$855.00 on October 7, 2016 and \$351.00 on October 14, 2016.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Medicaid for Adults between the Ages of 19 and 65

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$32,960.00 for a six-person household (82 Fed. Reg. 8831).

### Retroactive Medicaid

The Department of Health must make Medicaid coverage start retroactively for up to three months prior to the month of an initial application if the individual received medical services that would have been covered under Medicaid and the individual would have been eligible for Medicaid at the time he received the services if he had applied (42 USCA § 1396A(34); 42 CFR § 435.915(a)). The Department of Health may make eligibility effective for fee-for-service Medicaid on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

## **Legal Analysis**

The issue under review is whether NYSOH properly determined that you were not eligible for Medicaid for October 2016.

You are in a six-person household; you file your taxes with a tax filing status of married filing jointly and claim four dependent on your tax return.

You submitted an application for financial assistance on December 15, 2016 and requested help in paying for medical bills for the prior three months.

When an individual file an initial application for Medicaid, his or her eligibility for retroactive Medicaid depends on the date of application. To this end, it does not matter whether or not that initial application resulted in Medicaid going forward. Instead, an individual, who has filed an initial application for Medicaid through NYSOH, has the right to be evaluated for Medicaid for the three months before the month of his or her application.

Medicaid coverage can be made effective retroactively for up to three months prior to an individual's initial application if the individual received medical services

that would have been covered under Medicaid and if they would have been eligible for Medicaid in those three months had they applied.

You testified that you are seeking Medicaid for October 2016.

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size. To be eligible for Medicaid in October 2016, you would have needed to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$3,791.00 per month. There is no indication in the record that you would have been ineligible for Medicaid based on non-financial criteria during October 2016.

You testified that you are paid bi-weekly. You uploaded a paystub dated November 10, 2016 for a gross pay amount of \$540.00 and submitted a paystub report for your spouse from 2016, which states that he earned \$855.00 on October 7, 2016 and \$351.00 on October 14, 2016. You also submitted an IRS tax transcript for 2016, which states that your household's adjusted gross income for 2016 was \$13,739.00.

However, as you did not submit your paystubs for October 2016, you did not submit sufficient documentation to determine your household's income for October 2016. Since the documentation you provided is insufficient to calculate your household's income in October 2016, the Appeals Unit cannot determine if you qualify for retroactive Medicaid in the month of October 2016.

Since the September 5, 2017 eligibility determination notice properly stating that you were not eligible for retroactive Medicaid for October 2016 because you did not submit sufficient documentation of your household's income, it is correct and is AFFIRMED.

## **Decision**

The September 5, 2017 eligibility determination is AFFIRMED.
