Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your enrollment in an Essential Plan was effective September 1, 2017?

Procedural History

According to your NY State of Health (NYSOH) account and at NYSOH's request, you submitted proof of income documentation on July 13, 2017, which was validated by NYSOH on that same day [REDACTED]

On July 14, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to enroll in the Essential Plan, effective August 1, 2017. The notice stated that you needed to pick a health plan.

On August 9, 2017, NYSOH issued a plan enrollment notice stating that you were enrolled in an Essential Plan, and that your plan would start September 1, 2017.

On August 12, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in the Essential insofar as it did not begin August 1, 2017.

On October 27, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) According to your NYSOH account, you were found eligible to enroll in the Essential Plan on July 13, 2017.
- 2) You testified that you enrolled in an Essential Plan on July 13, 2017, by telephone.
- 3) According to two telephone audio call recordings, dated July 13, 2017, you called NYSOH and requested help accessing your online NYSOH account. There is no indication that you attempted to select a health plan during those conversations.
- 4) According to a written telephone call record, dated July 22, 2017, you attempted to select a health plan on that day.
- 5) You testified that you wanted your enrollment in an Essential Plan to begin on August 1, 2017, because you have a medical bill for that month, which you had to pay out of pocket.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the

fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); *see also* 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in the Essential Plan was effective September 1, 2017.

According to your NYSOH account, upon submitting proof of income documentation to NYSOH and that documentation being validated by NYSOH on July 13, 2017, you were found eligible to enroll in the Essential Plan.

You testified that you enrolled in your Essential Plan on July 13, 2017. However, a review of the call records indicates that you first attempted to enroll in your Essential Plan on July 22, 2017.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

Since the credible evidence of record supports that you selected an Essential Plan on July 22, 2017, your enrollment properly took effect on the first day of the second month following July 2017; that is, on September 1, 2017.

Therefore, the August 9, 2017 plan enrollment notice stating that your enrollment in the Essential Plan was effective September 1, 2017, is correct and must be **AFFIRMED**.

Decision

The August 9, 2017 plan enrollment notice is **AFFIRMED**.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

The effective date of your Essential Health Plan is September 1, 2017.

You did not have health insurance through NYSOH during August 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
