NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On July 11, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you and your child were eligible to receive an advance premium tax credit of up to \$385.00 per month, effective August 1, 2017. You appealed that determination.

On October 20, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because you and your child were subsequently found eligible to enroll in the Essential Plan with a \$20.00 monthly premium each for a limited time, effective October 1, 2017. You further stated that you would be providing the requested income documents directly to NYSOH by the November 14, 2017 due date so that the eligibility of you and your child for the Essential Plan could be confirmed.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
