Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your Medicaid Managed Care plan was effective, September 1, 2017?

Procedural History

On August 7, 2017, you submitted an application for financial assistance.

Your August 7, 2017 application stated that you were pregnant with one child with a due date of [REDACTED]

On August 8, 2017, NYSOH issued a notice of eligibility determination, based on your August 7, 2017 application, stating that you were eligible for Medicaid coverage for all outpatient prenatal Medicaid services which includes all Medicaid covered services except: inpatient care, alternate level care, institutional long term care, and long term home health care. The eligibility was effective, August 1, 2017.

On August 14, 2017, NYSOH received your updated application and you selected a health plan. On that date, a preliminary eligibility determination was prepared regarding that application, stating that your Medicaid Managed Care plan start date was September 1, 2017.

Also on August 14, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in your Medicaid Managed Care plan, insofar as it did not begin August 1, 2017.

On August 15, 2017, NYSOH issued a notice of enrollment in the plan you selected on August 14, 2017, stating that you were enrolled in a Medicaid Managed Care plan, and that your coverage would start on September 1, 2017.

On October 19, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on August 7, 2017.
- 2) You testified that you were pregnant at the time you applied for financial assistance on August 7, 2017.
- 3) NYSOH records reflect that you were determined eligible for Medicaid coverage, effective August 1, 2017.
- 4) You testified, and NYSOH records reflect, that you selected your Medicaid Managed Care Plan on August 14, 2017, and that your enrollment was effective on September 1, 2017.
- 5) You testified that you want your Medicaid Managed Care plan to begin on August 1, 2017 because you received medical services from [REDACTED] during August 2017 and your medical provider [REDACTED] does not accept Medicaid Fee-for-Service coverage.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR §

435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Legal Analysis

The issue is whether NYSOH properly determined that your enrollment in a Medicaid Managed Care plan was effective, September 1, 2017.

You applied to NYSOH for financial assistance on August 7, 2017. You testified and your account confirms that you were determined eligible for Medicaid coverage, effective August 1, 2017.

You testified that you contacted NYSOH on August 14, 2017 and enrolled into a Medicaid Managed Care plan.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On August 14, 2017, you selected a Medicaid Managed Care plan, so it properly took effect on the first day of the following month; that is, on September 1, 2017.

Therefore, the August 15, 2017 enrollment confirmation notice stating that your enrollment in your Medicaid Managed Care plan would be effective September 1, 2017, was correct and must be AFFIRMED.

Decision

The August 15, 2017 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

The effective date of your Medicaid Managed Care plan is September 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
