Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your youngest child was eligible for Medicaid, effective September 1, 2017?

Procedural History

On August 8, 2017, NY State of Health (NYSOH) received your updated application for financial assistance with health insurance.

On August 9, 2017, NYSOH issued an eligibility determination notice stating that your youngest child was eligible for Medicaid, effective September 1, 2017.

On August 14, 2017, you spoke to NYSOH's Account Review Unit and appealed that determination insofar as your youngest child was eligible for Medicaid, and not Child Health Plus.

On October 26, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are only appealing your youngest child's eligibility.
- 2) You testified that you do not claim your youngest child on your tax return.
- 3) You testified that your youngest child is claimed as a dependent by her mother, who does not live with you or the child.
- 4) You testified that your youngest child lives with you and her four siblings.
- 5) The record indicates that her four siblings are all under 19 years of age.
- 6) The application that was submitted on August 8, 2017 listed annual household income of \$43,923.06 in earnings from your employment. You testified that this amount was correct.
- 7) At the time of August 8, 2017 application, your youngest child was [REDACTED].
- 8) Your application states that you will not be taking any deductions on your 2017 tax return.
- 9) Your application states that you and your children live in [REDACTED].
- 10) According to your NYSOH account and your testimony, your youngest child has third party health insurance coverage through Tricare.
- 11) You testified that you applied for health insurance through NYSOH for your youngest child because there are no providers in your area that accept your youngest child's third-party health insurance.
- 12) You testified that you would like your youngest child to be eligible for Child Health Plus, and not Medicaid.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid for Children

A child who is at least one year of age but younger than nineteen is eligible for Medicaid if he or she meets the non-financial criteria and has a household modified adjusted gross income that falls at or below 154% of the federal poverty

level (FPL) for the applicable family size (42 CFR § 435.118(c); New York State Department of Social Services Administrative Directive 13 OHIP/ADM-03).

In the case where a child is claimed by a parent outside of the household, and will not be filing a tax return themselves, the child's household includes the following persons, if living with the child: (1) the child's parents, (2) the child's spouse, and (3) the child's children and siblings under the age of 19, or 21 if full-time students (42 CFR § 435.603 (f)(3)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which was \$32,960.00 for a six-person household (81 Federal Register 4036).

Third Party Health Insurance

A person who has primary medical or health care coverage available from or under a third-party insurance provider is not permitted to enroll into a Medicaid Managed Care plan (NY Social Services Law (NY SSL) § 364-j(3)(e)(xx); Medicaid Managed Care Model Contract (Appendix H-6), effective 3/1/2014 – 2/28/2019). However, they will remain eligible for fee-for-service Medicaid with limited exceptions, including entering prison or another facility that provides medical care, lack of state residence, or failing to provide a valid social security number (NY SSL § 366(4)(c)).

Child Health Plus

A child who meets the eligibility requirements for Child Health Plus (CHP) may be eligible to receive a subsidy payment if the child resides in a household with a household income at or below 400% of the federal poverty level (FPL) (New York Public Health Law (PHL) § 2511(2)(a)(iii)). To be eligible to enroll in CHP with subsidy payments, a child must not be "eligible for medical assistance"; that is, must not be eligible for Medicaid (NY Public Health Law § 2511(2)(b)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your youngest child was eligible for Medicaid, effective September 1, 2017.

According to the record, you will not claim your youngest child on your tax return. You testified that your youngest child is claimed by her mother and that her mother resides outside of the household. You testified, and the record reflects, that your youngest child's household consists of you, and her four siblings. Therefore, your child is in a six-person household for purposes of this analysis.

On your August 8, 2017 application, you attested to an expected household income of \$43,923.06. The record indicates that your child was [REDACTED] at the time of the application. NYSOH relied upon this information.

Medicaid can be provided through NYSOH to children between the ages of one and nineteen who meet the non-financial requirements and have a household modified adjusted gross income (MAGI) that is at or below 154% of the FPL for the applicable family size. On the date of your application, that was the 2017 FPL, which was \$32,960.00 for a six-person household. Since \$43,923.06 is 133.26% of the 2017 FPL for a six-person household, NYSOH properly found your youngest child to be eligible for Medicaid.

You testified that you want your youngest child enrolled in health coverage through Child Health Plus and not Medicaid. However, under New York State's Public Health Law, a Medicaid-eligible child does not qualify to enroll in health insurance through Child Health Plus.

Further, your youngest child is not eligible to enroll into a Medicaid Managed Care plan. When NYSOH determines that a person has active coverage in a health insurance plan outside of NYSOH, that person is not eligible to enroll or remain enrolled in a Medicaid Managed Care plan. Therefore, NYSOH was proper in finding your youngest child eligible for fee-for-service Medicaid, effective September 1, 2017.

Accordingly, the August 9, 2017 eligibility determination notice stating that your youngest child was eligible for Medicaid is correct and is AFFIRMED.

Decision

The August 9, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

Your youngest child remains eligible for Medicaid.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
