## lssue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your Medicaid Managed Care plan was effective August 1, 2017?

## **Procedural History**

On January 31, 2017, NYSOH issued a notice of eligibility determination, based on your January 30, 2017 application stating that you were eligible to enroll in the Essential Plan with a \$20.00 premium per month, effective March 1, 2017.

On January 31, 2017, NYSOH issued a notice of enrollment in the plan you selected on January 30, 2017, stating that you were enrolled in the Essential Plan, and that your coverage would start on March 1, 2017.

On August 17, 2017, NYSOH received your updated application for financial assistance. That day a preliminary eligibility determination was prepared stating you were eligible for Medicaid, effective August 1, 2017. You then enrolled in a Medicaid Managed Care plan that day with a start date of October 1, 2017.

Also on August 17, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in your Medicaid Managed Care plan, insofar as it did not begin September 1, 2017.

On August 18, 2017, NYSOH issued a notice of eligibility determination, based on your August 17, 2017 application, stating that you were eligible for Medicaid, effective August 1, 2017. The notice stated you no longer qualified for the Essential Plan, effective July 31, 2017.

Also on August 18, 2017 NYSOH issued a notice of enrollment in the plan you selected on August 17, 2017, stating that you were enrolled in a Medicaid Managed Care plan, and that your coverage would start on October 1, 2017.

Finally, on August 18, 2017, NYSOH issued a disenrollment notice stating your coverage in your Essential Plan would end on August 31, 2017.

On September 20, 2017, you requested an expedited appeal hearing.

Also on September 20, 2017, your request for an expedited appeal hearing was denied.

October 18, 2017, you were scheduled for a telephone hearing. A Hearing Officer called you and placed you under oath. You testified you were unable to proceed with a hearing at that time as you were ill and were on your way to **the second s** 

On October 23, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on August 17, 2017.
- 2) The application you submitted on August 17, 2017, resulted in your eligibility for Medicaid as of August 1, 2017.
- 3) You testified, and the record reflects, that you selected your Medicaid Managed Care Plan on August 17, 2017, and that your enrollment was effective on October 1, 2017.
- 4) You testified that you want your Medicaid Managed Care plan to begin on September 1, 2017 because you believe you may have medical bills which were not covered by Medicaid Fee for Service for that month.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### <u>Medicaid</u>

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

# Legal Analysis

The issue is whether NYSOH properly determined that your enrollment in the Medicaid Managed Care plan was effective October 1, 2017.

You testified that you contacted NYSOH on August 17, 2017 and enrolled into a Medicaid Managed Care plan after being determined eligible for Medicaid based on your application submitted that same day.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

Since on August 17, 2017, you selected a Medicaid Managed Care plan, it would properly take effect on the first day of the second month following August; that is, on October 1, 2017.

Therefore, the August 18, 2017 enrollment confirmation notice stating that your enrollment in your Medicaid Managed Care plan would be effective October 1, 2017, was correct and must be AFFIRMED.

## Decision

The August 18, 2017 enrollment confirmation is AFFIRMED.

## How this Decision Affects Your Eligibility

The effective date of your Medicaid Managed Care plan is October 1, 2017.

# If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
