## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly terminate your enrollment in your Essential Plan effective July 31, 2017 because of non-payment of premiums?

Did NYSOH properly determine that your enrollment in the Essential Plan was effective October 1, 2017?

## Procedural History

On October 21, 2016, NYSOH issued a renewal notice, stating that you qualified for the Essential Plan, effective January 1, 2017. The notice directed you to pick a plan between November 16, 2016 and December 15, 2016.

On December 1, 2016, NYSOH issued a notice of enrollment, based on your plan selection on November 30, 2016, stating that you were enrolled in an Essential Plan, and that your plan would start January 1, 2017.

On August 3, 2017, NYSOH issued a disenrollment notice, stating that your Essential Plan coverage would end on July 31, 2017, because you did not pay your insurance bill by the payment deadline.

On August 19, 2017, you selected a plan for reenrollment.

Also on August 19, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in the Essential insofar as it did not begin August 1, 2017.

On August 20, 2017, NYSOH issued an enrollment confirmation notice, stating that you were enrolled in the Essential Plan, effective October 1, 2017.

On October 26, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you were disenrolled from your Essential Plan for failure to pay premiums.
- 2) You testified that you travel and prefer to use auto-pay, but that the Essential Plan you selected did not offer auto-pay. You testified that you missed two payments because you had a hard time with the phone pay system.
- 3) You testified that you became aware of your disenrollment when you saw your doctor in August 2017.
- 4) You testified that you contacted NYSOH at the end of August 2017 to reenroll into an Essential Plan.
- 5) The record reflects that you contacted NYSOH to reenroll yourself in an Essential Plan on August 19, 2017.
- 6) You testified that you wanted your enrollment in an Essential Plan to begin on August 1, 2017 because you have outstanding medical bills for August 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Appealable Issues

An applicant has the right to appeal: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (3) an eligibility determination for an exemption, (4) a failure by the Exchange to provide timely notice of an eligibility determination and (5) a denial of a request to vacate dismissal made by the NY State of Health Appeals Unit (45 CFR § 155.505).

### Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

## **Legal Analysis**

The first issue under review is whether NYSOH properly terminated your enrollment in the Essential Plan effective July 31, 2017 because of non-payment of premiums.

The record indicates that you enrolled into the Essential Plan effective January 1, 2017. You testified that you missed two premium payments.

On August 3, 2017, NYSOH issued a cancellation notice stating that your coverage with the Essential Plan had been cancelled effective July 31, 2017 because a premium payment was not received by your plan within the required time frame.

The New York State of Health Appeals Unit only has the authority to review issues related to the following: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (3) an

eligibility determination for an exemption, (4) a failure by the Exchange to provide timely notice of an eligibility determination and (5) a denial of a request to vacate dismissal made by the New York State of Health Appeals Unit.

Since the Appeals Unit is not given the authority to review termination of enrollment due to non-payment of premiums, we cannot reach the merits as to whether or not you were properly terminated from your Essential Plans for non-payment of premiums. Therefore, your appeal of the August 3, 2017 disenrollment notice is DISMISSED as a non-appealable issue.

The second issue is whether NYSOH properly determined that your and your spouse's reenrollment in the Essential Plan was effective October 1, 2017.

The record indicates, that you selected an Essential Plan for enrollment on August 19, 2017.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On August 19, 2017, you selected an Essential Plan, so your enrollment properly took effect on the first day of the second month following August 2017; that is, on October 1, 2017.

Therefore, the August 20, 2017 enrollment confirmation notice stating that your enrollment in the Essential Plan was effective October 1, 2017, is correct and must be AFFIRMED.

## **Decision**

The appeal of the August 3, 2017 disenrollment notice is DISMISSED.

The August 20, 2017 enrollment confirmation notice is AFFIRMED.

## **If You Disagree with this Decision (Appeal Rights)**

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
